REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT, AND RESPONSE TO COMMENTS FOR JOINT OUTFALL SYSTEM – JOINT WATER POLLUTION CONTROL PLANT, CARSON, CALIFORNIA (NPDES NO. CA0053813, CI NO. 1758)

Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) staff have revised the tentative WDRs and NPDES permit dated March 30, 2023, based on written comments received by the May 1, 2023 public comment deadline. Written comments are not being solicited regarding the revised tentative Order.
