THE REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT RENEWAL – LOS ANGELES-GLENDALE WATER RECLAMATION PLANT, LOS ANGELES, CA (NPDES PERMIT NO. CA0053953, CI-5675)

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) staff has revised the tentative WDRs and NPDES permit dated October 14, 2022, based on all comments received by the November 14, 2022 public comment deadline. Written comments are not being solicited regarding the revised tentative Order.
