TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR NEWHALL RANCH SANITATION DISTRICT – NEWHALL RANCH WATER RECLAMATION PLANT (NEWHALL RANCH WRP), (NPDES NO. CA0064556, CI#9322)

The Los Angeles Regional Water Quality Control Board has completed its review of the application for renewal of the Newhall Ranch Sanitation District's Newhall Ranch Water Reclamation Plant (Newhall Ranch WRP) NPDES permit to discharge wastes into Reach 5 of the Santa Clara River.

Pursuant to the Federal Clean Water Act, as amended, and in accordance with the California Water Code, tentative waste discharge requirements have been prepared.

It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff. Written comments regarding this tentative Order must be received at the Regional Water Board office by **5:00 p.m. on February 15, 2019**, in order to be evaluated by Board staff and included in the Board's agenda folder. Comments received after that date will not be considered, absent extraordinary circumstances. Timely submittal of written comments is required to ensure that all comments are accurately and fully included in the administrative record, that Board staff is able to provide timely review, and that Regional Board members have sufficient time to give full consideration to the comments and issues raised.

With respect to the public notices, in accordance with the Federal Clean Water Act, as amended, and the California Code of Regulations, you are required to follow the enclosed instructions for publication or posting of the notice no later than **February 1, 2019**.

Failure to publish or post the notice by the above date may require us to reschedule this item for a later hearing and will require the publication or posting of a second notice. Please notify this Board by telephone when the notice has been published and submit the proof of publication or posting as required in the enclosed instructions. Proof of posting or publication of the notice must be received by the Executive Officer of this Regional Water Board no later than **February 8**, **2019**.
