PROPOSED TERMINATION OF WASTE DISCHARGE REQUIREMENTS (National Pollutant Discharge Elimination System Permit)

Northrop Grumman Systems Corporation owns and operates the Former TRW Benchmark Site (Facility) located at 200 South Turnbull Canyon Road, City of Industry, California. The Facility is regulated by Order R4-2004-0169, which was adopted on December 13, 2004, and expired on October 10, 2009. Order Number R4-2004-0169 was administratively continued until reissuance of a new permit. In a letter dated March 15, 2021, the Discharger requested termination of the NPDES permit because no further discharge will occur at this site.

A groundwater treatment system was previously installed at the Facility to treat groundwater contaminated with volatile organic compounds (VOCs) and 1,4-dioxane that resulted from accidental spills, leaks, and routine handling of chlorinated solvents, acids, bases, heavy metals and other chemicals used as part of the manufacturing process for printed circuit boards at the location from 1955 until its closure in 1989. The site has been redeveloped and is currently used as a warehousing facility for a furniture wholesaler. The Facility is permitted to discharge up to 0.216 million gallons per day (MGD) of treated groundwater to the San Jose Creek. The groundwater treatment system at the Facility has not operated nor discharged since 2008; when the water levels had dropped, such that pumping and remediation operations ceased. The treatment system was dismantled in 2013, but the piping infrastructure remains intact. The Discharger retained the NPDES permit for when a downgradient groundwater treatment system is installed.

On August 6, 2020, the U.S. EPA approved the design for the Shallow Zone (SZ) South Interim Remedy Treatment Facility (new treatment system). The construction of the new treatment system will start in January 2021, under the direction of U.S. EPA as part of the San Gabriel Valley (Area 4) Superfund Site, Puente Valley Operable Unit (PVOU). The new treatment system will be located at 111 Hudson Avenue in the City of Industry, downgradient from the Facility to treat and discharge groundwater impacted by VOCs and 1,4-dioxane attributable to the former TRW Benchmark site located at 200 S.

Turnbull Canyon Road. Northrop Grumman owns the property located at 111 Hudson Avenue and has an existing NPDES permit (General NPDES Permit No. CAG994004, Order No. R4-2008-0032, *Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters*), for the discharge of treated groundwater for the Intermediate Zone Interim Remedy. The General NPDES permit provides regulatory coverage for the discharge of treated groundwater from the new treatment system located at 111 Hudson Avenue in the City of Industry. Therefore, no further discharge will occur at the Facility located at 200 S. Turnbull Canyon Road in the City of Industry.

On the basis of preliminary staff review and application of lawful standards and regulations, the Los Angeles Water Board proposes to terminate Order R4-2004-0169.
