Proof of posting shall consist of a statement executed on the enclosed form; proof of publication shall consist of an affidavit of the publisher or foreman of the newspaper, with a copy of the notice as published, attached. Proof of posting or publication must be submitted to this Regional Water Board by May 28, 2013.

Failure to post or publish the public notice by the specified date may require us to reschedule this item for a later hearing and will require the posting or publication of a second notice.
