# Public Notice Number 21-011 NOTICE OF PROPOSED ISSUANCE OF WASTE DISCHARGE REQUIREMENTS

(National Pollutant Discharge Elimination System Permit)

The Joint Outfall System (JOS), formerly referred to as Los Angeles County Sanitation District is currently discharging tertiary-treated effluent, from its San Jose Creek Water Reclamation Plant (San Jose Creek WRP) to San Jose Creek and San Gabriel River, waters of the United States. The discharge is regulated under waste discharge requirements contained in Order No. R4-2015-0070, adopted by the California Regional Water Quality Control Board Los Angeles Region (Los Angeles Water Board), on April 09, 2015. Order No. R4-2015-0070 serves as a permit under the National Pollutant Discharge Elimination System (NPDES No. CA0053911). The Discharger filed a report of waste discharge (ROWD) and applied for reissuance of its Waste Discharge Requirements (WDRs) and NPDES permit on December 3, 2019, to discharge tertiary-treated effluent. Supplemental information was requested on February 24, 2020 and received on March 19, 2020. The application was deemed complete on March 23, 2020. The terms and conditions of the current NPDES order have been automatically continued and remain in effect until new WDRs and NPDES permit are adopted pursuant to this Order.

JOS owns and operates the San Jose Creek WRP, a publicly owned treatment works (POTW), located at 1965 South Workman Mills Road, Whittier, California, with a design capacity of 100 million gallons per day (MGD). The Facility consists of East and West WRPs. The two WRPs independently utilize the same process trains which include influent pumping, primary sedimentation, activated sludge biological treatment with nitrification/denitrification, secondary sedimentation, coagulation, inert media filtration, chloramination for disinfection, and dechlorination (sodium bisulfite). The San Jose Creek WRP and six other POTWs are part of an integrated network of facilities, known as the JOS. The JOS, which consists of approximately 1,200 miles of interceptors and trunk sewers, serves an urban area of 654 square miles, including all or parts of 73 cities in addition to multiple communities and unincorporated areas, within Los Angeles County. Sewage solids, separated from the San Jose Creek WRP's wastewater are returned to the JOS trunk sewer for conveyance to Joint Water Pollution Control Plant (JWPCP) for treatment and disposal, under a separate NPDES Order. Tertiary-treated effluent is discharged from the San Jose Creek WRP at the following discharge points to the specified waters of the United States, within the San Gabriel River Watershed: 1) Discharge Point 001 (Latitude 33.930613 N, Longitude 118.107791 W) to the San Gabriel River, 2) Discharge Point 001A (Latitude 33.994405 N, Longitude 118.073476 W) to the San Gabriel River 3) Discharge Point 001B (Latitude 33.969771 N, Longitude 118.088866 W) to the San Gabriel River, 4) Discharge

Point 002 (Latitude 34.035446 N, Longitude 118.021100 W) to the San Jose Creek, and 5) Discharge Point 003 (Latitude 34.036081 N, Longitude 118.030631 W) to the San Gabriel River. Proposed future discharges to the San Gabriel River are Discharge Point 004 (Latitude 34.111125 N, Longitude 117.971036 W) and Discharge Point 005 (Latitude 34.131603 N, Longitude 117.950228 W).

On the basis of preliminary staff review and application of lawful standards and regulations, the Los Angeles Water Board tentatively proposes to issue waste discharge requirements, including effluent limitations and special conditions.

#### NATURE OF HEARING

This will be a formal adjudicative hearing pursuant to section 648 et seq. of title 23 of the California Code of Regulations. Chapter 5 of the California Administrative Procedure Act (commencing with section 11500 of the Government Code) will not apply to this proceeding.

# **HEARING PROCEDURE**

The meeting, in which the hearing will be a part of, will start at 9:00 a.m. Interested persons are invited to attend. Staff will present the matter under consideration, after which oral statements from parties or interested persons will be heard. For accuracy of the record, all important testimony should be in writing. The Board will include in the administrative record written transcriptions of oral testimony that is presented at the hearing. Oral testimony may be limited to three minutes maximum or less for each speaker, depending on the number of persons wishing to be heard. Parties or persons with similar concerns or opinions are encouraged to choose one representative to speak. At the conclusion of testimony, the Board will deliberate in open or close session, and render a decision.

Parties or persons with special procedural requests should contact staff. Any procedure not specified in this hearing notice will be waived pursuant to section 648(d) of title 23 of the California Code of Regulations. Objections to any procedure to be used during this hearing must be submitted

in writing not later than close of business fifteen business days prior to the date of the hearing. Procedural objections will not be entertained at the hearing.
