REQUEST FOR COMMENTS ON THE TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR TORRANCE REFINING COMPANY, LLC, - TORRANCE REFINERY (NPDES NO. CA0055387, CI NO. 5742)

The Los Angeles Regional Water Quality Control Board (Regional Board) staff have completed its review of your application for renewal of your permit to discharge waste under the National Pollutant Discharge Elimination System (NPDES) Program.

Pursuant to the Federal Clean Water Act, as amended, and in accordance with the California Water Code, tentative waste discharge requirements have been prepared.

Written comments regarding the tentative waste discharge requirements must be submitted to the Regional Board staff at <u>losangeles@waterboards.ca.gov</u> with a copy submitted to Mazhar Ali at <u>mazhar.ali@waterboards.ca.gov</u> no later than **5:00 p.m. on May 13, 2019**, in order to be evaluated by Board staff and included in the Board's agenda folder. Comments or evidence received after that date and time will not be included in the record or considered by the Regional Board, without express approval by the Regional Board. (See Cal. Code Regs., tit. 23, § 648.4.) Timely submittal of written comments is encouraged to ensure that all comments are accurately and fully included in the administrative record, that Regional Board staff is able to provide timely review, and that Regional Board members have sufficient time to give full consideration to the comments and issues raised.

With respect to the public notices, in accordance with the Federal Clean Water Act, as amended, and the California Code of Regulations, you are required to follow the enclosed instructions for publication or posting of the notice not later than April 17, 2019.

Please notify this Regional Board by telephone when the notice has been published and submit the proof of publication or posting as required in the enclosed instructions. Proof of posting or publication of the notice must be received by the Executive Officer of this Regional Board no later than April 22, 2019.
