
TRANSMITTAL OF REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR CITY OF VENTURA, VENTURA WATER RECLAMATION FACILITY (NPDES NO. CA0053651, CI NO. 1822)

We have revised the tentative WDRs and NPDES permit dated December 3, 2019, based on comments received by the January 6, 2020, public comment deadline. A copy of the revised tentative Order, comments received, and written responses to all comments received are enclosed. Changes to the tentative WDRs appear in strikeout and underline format. Written comments are not being solicited regarding the revised tentative Order.
