**NOTICE OF PUBLIC HEARING
Public Notice No. 25-009**

**PROPOSED ISSUANCE OF
WASTE DISCHARGE REQUIREMENTS AND
NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT**

The City of Ventura (City of Discharger) owns and operates the Ventura Water Reclamation Facility (VWRF), a publicly owned treatment works located at 1400 Spinnaker Drive, Ventura, California. The City currently discharges an annual average of up to 9 million gallons per day (MGD) of tertiary-treated wastewater from the VWRF to the Santa Clara River Estuary (Estuary) via Discharge Point 001 (Latitude: 34.23937°N, Longitude: 119.25870°W). The City is required to divert treated wastewater from the Estuary under a consent decree with Wishtoyo Foundation/Ventura Coastkeeper and Heal the Bay to improve the Estuary's water quality. In order to divert the treated wastewater from the Estuary, the City is implementing a series of projects to improve water quality and to create a new resilient water supply for the City by prioritizing reuse of the effluent from the VWRF. The VWRF will be undergoing upgrades that will produce a higher quality effluent that will be conveyed to an Advanced Water Purification Facility (AWPF). The AWPF will produce advanced-treated recycled water that will be used to recharge the groundwater basin and help the City meet future potable water demands. A new ocean outfall has been constructed to divert discharge of tertiary-treated wastewater from the Estuary and to convey reverse osmosis concentrate from the AWPF to the Pacific Ocean, a water of the United States, at Discharge Point 002 (Latitude: 34.253103°N, Longitude: 119.290653°W). The Estuary discharge is currently regulated under Waste Discharge Requirements (WDRs) and National Pollutant Discharge Elimination System (NPDES) permit (CA0053651) contained in Order No. R4-2020-0024 (Estuary Discharge Permit), adopted by the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) on February 13, 2020. The Discharger filed a Report of Waste Discharge (ROWD) and applied for reissuance of the WDRs and NPDES permit on October 2, 2024, to discharge tertiary-treated effluent to the Estuary and tertiary-treated effluent and reverse osmosis concentrate to the Pacific Ocean. The application was deemed complete on January 16, 2025. On September 5, 2025, Los Angeles Water Board and City staff discussed the schedule for the revision and reissuance of the Estuary Discharge Permit to authorize discharges from the VWRF to the ocean and agreed that the Los Angeles Water Board should issue a separate NPDES permit for the ocean outfall instead of consolidating the Estuary outfall and the ocean outfall into a single permit at

this time. As a result, this Order only regulates the discharge from the VWRF to the Pacific Ocean. The Estuary Discharge Permit will continue to remain in effect until it is revised and/or terminated.

On the basis of preliminary staff review and application of lawful standards and regulations, the Los Angeles Water Board tentatively proposes to issue WDRs and the NPDES permit under Title 40 of the Code of Federal Regulations (40 CFR) § 124.4(c)(2).

The Los Angeles Water Board will hold a public hearing on the Tentative WDRs and NPDES permit during the regular Los Angeles Water Board meeting (Board meeting) on the following date and time and at the following location:

Interested persons are invited to attend. At the public hearing, the Los Angeles Water Board will hear any testimony pertinent to the discharge, tentative WDRs, and NPDES permit. Oral testimony will be heard; however, for accuracy of the record, important testimony should be in writing.

The entire file (ROWD, other documents relied upon to develop tentative effluent limitations and special provisions, comments received, and other information) will become a part of the administrative record of this proceeding, irrespective of whether individual documents are specifically referenced during the hearing. The entire file will not be present in the hearing room. Should any interested persons desire staff to bring to the hearing any documents that are not included in the agenda packet, they must submit a

written or electronic request to staff during business hours no later than five business days before the hearing. The request must identify the documents with enough specificity for staff to locate them.

NATURE OF HEARING

This will be a formal adjudicative hearing pursuant to section 648 et seq. of title 23 of the California Code of Regulations. Chapter 5 of the California Administrative Procedure Act (commencing with section 11500 of the Government Code) will not apply to this proceeding.

Ex Parte Communications Prohibited: As a quasi-adjudicative proceeding, no board member may discuss the subject of this hearing with any person, except during the public hearing itself. Any communications to the Los Angeles Water Board must be directed to staff.

To be evaluated and responded to by the Los Angeles Water Board staff, included in the Los Angeles Water Board's agenda folder, and fully considered by the Los Angeles Water Board, written comments or testimony regarding the tentative documents must be received no later than **5:00 p.m. on November 13, 2025**. Failure to comply with these requirements is grounds for the Los Angeles Water Board to refuse to admit the proposed written comment or exhibit into evidence pursuant to section 648.4, title 23 of the California Code of Regulations.

HEARING PROCEDURE

The Board meeting, of which this hearing is a part, will start at 9:00 a.m. Interested persons are invited to attend. When the agenda item is called, staff will present the matter under consideration, after which oral statements from parties or interested persons will

be heard. For accuracy of the record, all important testimony should be in writing. The Los Angeles Water Board will include in the administrative record written transcriptions of oral testimony that is actually presented at the hearing. Oral testimony may be limited to five minutes or less for each interested person, depending on the number of interested persons wishing to be heard.

Parties or interested persons with similar concerns or opinions are encouraged to choose one representative to speak and are encouraged to coordinate their presentations with each other. Parties will be advised after the receipt of public comments, but prior to the date of the hearing, of the amount of time each is allocated for presentations. That decision will be based upon the complexity and number of issues under consideration, the extent to which the parties have coordinated, the number of parties and interested persons anticipated, and the time available for the hearing. The parties are invited to contact staff no later than **December 4, 2025**, (two weeks prior to the hearing) to discuss how much time they believe is necessary for their presentations, and staff will endeavor to accommodate reasonable requests. At the conclusion of testimony, the Board will deliberate in open or closed session, and render a decision.

The Board meeting does not generally require the prior identification of witnesses, the cross examination of witnesses, or other procedures not specified in this notice. Parties or persons with special procedural requests or requests for alternative hearing procedures should contact staff, who will endeavor to accommodate reasonable requests. Objections to any procedure to be used during this hearing must be submitted in writing no later than close of business 15 business days prior to the date of the hearing. (Any objections related to the amount of time allocated for parties' presentations must be submitted within two business days of notice thereof, if that date is less than 15 business days before the hearing.) Absent such objections, any procedure not specified in this hearing notice will be waived pursuant to section 648(d) of title 23 of the California Code of Regulations. Procedural objections will not be entertained at the hearing.

If there should not be a quorum on the scheduled date of this meeting, all cases will be automatically continued to the next scheduled meeting on **February 19, 2026**. A continuance will not extend any time set forth herein.
