REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – WEST BASIN MUNICIPAL WATER DISTRICT, EDWARD C. LITTLE WATER RECYCLING FACILITY, EL SEGUNDO, CA (NPDES PERMIT NO. CA0063401, CI-7449)

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) staff has revised the tentative WDRs and NPDES permit dated September 13, 2023, based on all comments received by the October 13, 2023 public comment deadline. Written comments are not being solicited regarding the revised tentative Order.
