CHANGE SHEET FOR REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT, AND RESPONSE TO COMMENTS FOR CITY OF LOS ANGELES, HYPERION TREATMENT PLANT (NPDES NO. CA0109991, CI NO. 1492)

The Los Angeles Regional Water Quality Control Board (Regional Water Board) staff has revised the revised tentative WDRs and NPDES permit dated January 20, 2017, due to a miscalculation of the chronic toxicity in-stream waste concentration (IWC) for the 1-Mile Outfall and to make the copper monitoring requirements consistent with the revisions made in the Revised Tentative Order. A copy of the Change Sheet is enclosed. Changes to the revised tentative WDRs appear in ~~strikeout~~ and underline format. Written comments are not being solicited regarding the Change Sheet or the Revised Tentative Order.

In accordance with administrative procedures, the United States Environmental Protection Agency (USEPA) and the Regional Water Board staff will make a recommendation to the Regional Water Board members for consideration and disposition at a public meeting to be held on **February 02, 2017, at 9:00 a.m., at the Metropolitan Water District of Southern California Board Room, 700 North Alameda Street, Los Angeles, California**. Note that the USEPA and Regional Water Board held a joint public hearing on October 13, 2016, following a written comment period. At the October hearing, the Regional Water Board closed the comment period and no additional comments were accepted.
