Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) staff has revised the tentative WDRs and NPDES permit dated October 20, 2023, based on written comments received by the November 20, 2023 public comment deadline. A copy of the revised tentative Order and written responses to all comments received are enclosed. Changes to the tentative Order appear in strikeout and underline format. Written comments are not being solicited regarding the revised tentative Order.

The Los Angeles Water Board will hear any testimony pertinent to the revised tentative Order. It is expected that the Los Angeles Water Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff.
