RESPONSE TO COMMENTS ON THE TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – ZENITH ENERGY WEST COAST TERMINALS LLC, DOMINGUEZ HILLS TANK FARMS WILMINGTON, CALIFORNIA (NPDES NO. CA0052949, CI NO. 5841)

Dear Ms. Cunningham:

On September 22, 2023, the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) transmitted the tentative Waste Discharge Requirements (WDRs) and National Pollutant Discharge Elimination System (NPDES) permit for the Dominguez Hills Tank Farms (Facility). The Los Angeles Water Board considered all comments submitted by October 23, 2023. Enclosed are our response to comments and the revised tentative Order.

The Los Angeles Water Board will consider the Tentative Permit at a public hearing to be held on **November 16, 2023, at 9:00 A.M.** The hearing will be held at the following address:
