TENTATIVE AMENDMENT TO TIME SCHEDULE ORDER (TSO) FOR SANTA CLARITA VALLEY SANITATION DISTRICT OF LOS ANGELES COUNTY (SCVSD), SAUGUS WATER RECLAMATION PLANT, ORDER NO. R4-2019-0056-AXX (CI NO 2960)

The Regional Water Quality Control Board, Los Angeles Region (Los Angeles Water Board) received SCVSD's correspondence requesting an extension of the time schedule for chloride in Time Schedule Order (TSO) No. R4-2019-0056-A01 beyond the January 31, 2022 deadline.

Pursuant to California Water Code sections 13385 (j)(3)(B)(i) and 13385 (j)(3)(C)(i), a tentative amended TSO has been prepared. Enclosed are copies of the tentative amended TSO and the Notice of Public Hearing of the tentative amended TSO.

In accordance with administrative procedures, this Board at a public hearing to be held on **July 8, 2021, at 9:00 A.M.**, via a remote meeting, will consider the enclosed tentative amended TSO, and comments submitted in writing regarding any and all portions thereof. The Board will hear any testimony pertinent to this discharge and the tentative amended TSO. It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff. The agenda for the meeting will be posted on the Los Angeles Water Board Board's website (http://www.waterboards.ca.gov/losangeles/board_info/agenda/index.shtml) approximately one week prior to the meeting.

Written comments regarding this tentative amended TSO must be received at the Los Angeles Water Board office by **5:00 p.m. on June 9, 2021**, in order to be evaluated by Board staff and included in the Board's agenda folder. Comments received after that date will not be considered, absent extraordinary circumstances. Timely submittal of written comments is encouraged to ensure that all comments are accurately and fully included in the administrative record, that Board staff is able to provide timely review, and that Los Angeles Water Board members have sufficient time to give full
