**REVISED TENTATIVE TIME SCHEDULE ORDER (TSO), RESPONSE TO COMMENTS, AND CHANGE OF VENUE NOTIFICATION - SANTA CLARITA VALLEY SANITATION DISTRICT:
- VALENCIA WATER RECLAMATION PLANT (VALENCIA WRP), (CI-4993)
- SAUGUS WATER RECLAMATION PLANT (SAUGUS WRP), (CI-2960)**

The Regional Water Board has revised the Tentative Time Schedule Orders (TSOs) for the Santa Clarita Valley Sanitation District's Valencia and Saugus Water Reclamation Plants (WRPs), dated March 12, 2019, based on comments received by the April 10, 2019, public comment deadline. A copy of the Revised Tentative TSOs and written responses to all comments received are enclosed. Changes to Revised Tentative TSOs appear in strikethrough and underline format.

Notice is being provided that there has been a change of venue for the public hearing. It will no longer take place at the City of Malibu. In accordance with administrative procedures, this Board at a public hearing to be held on **May 9, 2019, at 9:00 a.m.**, at the **City of Agoura Hills (Council Chambers), 30001 Ladyface Court, Agoura Hills, California 91301**, will consider the enclosed Revised Tentative TSOs and written comments received by April 10, 2019, regarding any and all portions thereof. The Board will hear any testimony pertinent to these two Revised Tentative TSOs. It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff. The agenda for the meeting will be posted on the Los Angeles Regional Water Quality Control Board's website (http://www.waterboards.ca.gov/losangeles/board_info/agenda/index.shtml) approximately one week prior to the meeting.


Additional written comments regarding these Revised Tentative TSOs are not being solicited because the public comment deadline has past.
