TRANSMITTAL OF TIME SCHEDULE ORDER FOR VOPAK TERMINAL LONG BEACH INC., VOPAK TERMINAL LONG BEACH INC. FACILITY, SAN PEDRO, CA (NPDES NO. CA0064165, CI NO. 7873)

Our letter dated March 9, 2017, transmitted the tentative Time Schedule Order (TSO) to Vopak Terminal Long Beach Inc. Facility (Facility), and provided an opportunity for public comment. The comment submittal deadline specified was April 10, 2017. The Facility is currently regulated under waste discharge requirements contained in Order No. R4-2016-0142, adopted by this Regional Water Board on April 14, 2016. The TSO included interim effluent limitations for copper and zinc in discharges from the Facility through Discharge Point 001. The TSO will provide the required time to make infrastructure changes and implement appropriate control measures to bring the Vopak Terminal Long Beach Inc. Facility's discharge into compliance with the final limitations for copper and zinc. The interim limitations for these pollutants will expire on August 31, 2017.

Regional Water Board staff did not receive comments regarding the tentative TSO. Therefore, the Executive Officer, pursuant to his delegated authority from the Regional Water Board, administratively issues this Time Schedule Order No. R4-2017-0104 without a public hearing. The TSO will become effective on April 13, 2017.

A hard copy of this TSO will be sent only to the Discharger. Other interested parties will receive a copy via email. The TSO is also available on the Regional Water Board's website: www.waterboards.ca.gov/losangeles/.
