TENTATIVE ORDER TO TERMINATE WASTE DISCHARGE REQUIREMENTS - ARROW NU-WAY RECLAMATION, IRWINDALE, CALIFORNIA (FILE NO. 01-084, ORDER NO. R4-2016-0332, CI-8316, GEOTRACKER GLOBAL NO. L10002905176)

Dear Mr. Edwards:

On October 13, 2016, the Los Angeles Regional Water Quality Control Board (Regional Water Board) adopted Waste Discharge Requirements (WDRs) Order No. R4-2016-0332, for the discharge of inert wastes at the Arrow Nu-Way Reclamation (Landfill) in Irwindale, California, that is owned by Irwindale Partners, LP and operated by Arcadia Reclamation Inc. In a letter dated March 17, 2022, you requested termination of Order No. R4-2016-0332 because the permitted discharge of wastes at the site had ceased.

In accordance with administrative procedures, this Regional Water Board, at a public hearing, will consider the enclosed tentative Order, which will terminate WDRs Order No. R4-2016-0332. The hearing will be held on **July 14, 2022**, at the Ventura County Government Center, Board of Supervisors Hearing Room, 800 S. Victoria Avenue, Ventura, CA, and will begin at 9:00 AM.

In order to be fully evaluated by Regional Water Board staff and included in the Board's agenda packet, written comments must be received at the Regional Water Board office by 5:00 PM on **June 20, 2022**. Failure to comply with these requirements is grounds for the Regional Water Board to refuse to admit the proposed written comments or exhibits into evidence. Timely submittal of written comments is encouraged to ensure that all comments are accurately and fully included in the administrative record, that Regional Water Board staff is able to provide a timely review, and that Regional Water Board members have sufficient time to give full consideration to the comments and issues raised.
