TENTATIVE TERMINATION OF GENERAL WASTE DISCHARGE REQUIREMENTS FOR DISCHARGE OF NON-HAZARDOUS CONTAMINATED SOILS AND OTHER WASTES TO CLASS III LANDFILLS (Order No. 91-93, File No. 88-57)

The Los Angeles Regional Water Quality Control Board (Regional Water Board) adopted General Waste Discharge Requirements (General WDRs) Order No. 91-93 on July 22, 1991, for the discharge of non-hazardous contaminated soil and other similar wastes to properly engineered and managed waste management units. As provided in the enclosed tentative Order, the Regional Water Board staff finds that requirements contained in the General WDRs are no longer necessary and proposes that Order No. 91-93 be terminated.

In accordance with administrative procedures, this Regional Water Board, at a public hearing to be held on **September 10, 2020**, will consider the enclosed tentative Order, which will terminate General WDRs Order No. 91-93. As a result of the COVID-19 emergency and the Governor's Executive Orders to protect public health by limiting public gatherings and requiring social distancing, it is expected that the public hearing will be conducted via remote presence with video and teleconference meeting only, unless otherwise announced.

In order to be fully evaluated by Regional Water Board staff and included in the Regional Water Board's agenda packet, written comments must be received at the Regional Water Board office by 5:00 PM on **August 21, 2020**. Failure to comply with these requirements is grounds for the Regional Water Board to refuse to admit the proposed written comments or exhibits into evidence. Timely submittal of written comments is encouraged to ensure that all comments are accurately and fully included in the administrative record, that Regional Water Board staff is able to provide a timely review, and that Regional Water Board members have sufficient time to give full consideration to the comments and issues raised.
