## ORDER NO. R4-2021-XXXX

TERMINATION OF INDIVIDUAL WASTE DISCHARGE REQUIREMENTS
FOR DISCHARGES TO LAND/GROUNDWATER
(LOS ANGELES ACADEMY MIDDLE SCHOOL)
File No. 13-141

The California Regional Water Quality Control Board, Los Angeles Region (Regional Water Board) finds:

- On April 10, 2014, the Regional Water Board adopted individual Waste Discharge Requirements (WDRs) contained in Order No. R4-2014-0038 along with Monitoring and Reporting Program (MRP) No. CI-10008 for the Los Angeles Unified School District to inject water with emulsified vegetable oil, a chlorinatedethene degrading microbial consortium, and other amendments into groundwater to remediate chlorinated volatile organic compounds (CVOCs), at 644 East 56<sup>th</sup> Street, Los Angeles, California 90011 (Site).
- 2. On March 21, 2017, the Discharger submitted a Report of Waste Discharge (ROWD) to the Regional Water Board for coverage under Regional Water Board Order No. R4-2014-0187, General Waste Discharge Requirements for In-situ Groundwater Remediation and Groundwater Re-injection (General WDRs), for the injection of a bioaugmentation emulsion into groundwater to remediate CVOCs beneath the Site. The General WDRs authorize the use of a variety of materials for in-situ remediation purposes. Enrollment under the General WDRs streamlines the permitting process for these high priority remediation projects and, where applicable, has replaced the need for issuance of individual WDRs.
- 3. On April 27, 2017, the Regional Water Board enrolled the Discharger under General Order No. R4-2014-0187, Series No. 096.
- 4. Because the activity is adequately regulated under the General WDRs, the individual WDRs set forth in Order No. R4-2014-0038 covering amendment injection associated with bioremediation of CVOCs are no longer needed, and Order No. R4-2014-0038 shall be terminated except for purposes of enforcement.
- 5. The termination of individual WDRs (Order No. R4-2014-0038) is exempt from the California Environmental Quality Act because the termination of WDRs and the discharge authorized by the WDRs does not have the potential for causing a significant impact on the environment. See Title 14, Cal. Code Regs. § 15061(b)(3).

The Regional Water Board has notified the Discharger and interested agencies and persons of its intent to consider termination of Order No. R4-2014-0038 and MRP No. CI
