TERMINATING WATER RECLAMATION REQUIREMENTS FOR COUNTY SANITATION DISTRICTS OF LOS ANGELES COUNTY, LOS COYOTES WATER RECLAMATION PLANT, ORDER NO. 87-051 (CI NO. 6182)

The California Regional Water Quality Control Board, Los Angeles Region (Regional Water Board), finds:

- 1. The Regional Water Board issued Water Reclamation Requirements (WRRs) contained in Order No. 87-051, which were readopted without revision through Order No. 97-072, for the Los Coyotes Water Reclamation Plant, operated by the Joint Outfall System (Discharger). The WRRs regulate the production, distribution, and reuse of recycled water for non-potable applications.
- 2. The Discharger has now enrolled under the State Water Resources Control Board (State Water Board) Water Quality Order No. WQ 2016-0068-DDW, Water Reclamation Requirements for Recycled Water Use that regulates the production, distribution, and reuse of recycled water for non-potable applications.
- 3. Therefore, the individual WRRs contained in Order No. 87-051, and which were readopted without revision through Order No. 97-072, are no longer necessary and should be terminated.
- 4. The Regional Water Board has notified the Discharger, interested agencies, and persons of its intent to consider termination of these individual WRRs and has provided them with an opportunity to submit written comments.
- 5. This rescission of WRRs is covered by the common sense exemption. (Cal. Code Regs., tit. 40, §15061.) There is no possibility that the rescission of these WRRs may have a significant effect on the environment because the discharge will continue to be regulated under the State Water Board Order.
- 6. The Regional Water Board, in a public hearing, heard and considered all comments and testimony pertinent to this matter.

IT IS HEREBY ORDERED that the following water reclamation requirements be terminated except for enforcement purposes:
