ORDER NO. R4-2023-YYYY

TERMINATING WATER RECYCLING REQUIREMENTS
FOR REUSE OF RECYCLED WATER OVER THE LAS POSAS VALLEY
GROUNDWATER BASIN

The California Regional Water Quality Control Board, Los Angeles Region (Los Angeles Water Board), finds:

1. On January 24, 2002, the Los Angeles Water Board issued individual Water Recycling Requirements Order No. R4-2002-0028 to regulate the production, distribution, and reuse of disinfected tertiary recycled water from the Moorpark Water Reclamation Facility (WRF) for direct, non-potable applications.
2. The Ventura County Waterworks District No. 1 (VCWD) is the owner and operator of the Moorpark WRF, and is the sole permittee in Order No. R4-2002-0028.
3. On April 27, 2023, the Los Angeles Water Board adopted Order No. R4-2023-XXXX, which includes Waste Discharge Requirements (WDRs) for the discharge of treated effluent to percolation ponds at the Moorpark WRF and Water Reclamation Requirements (WRRs) to regulate the production, distribution, and reuse of disinfected tertiary recycled water for non-potable applications by the Discharger.
4. Since all requirements from the WRRs (Order No. R4-2002-0028) were transferred and incorporated to the WDRs/WRRs (Order No. R4-2023-XXXX), the Water Recycling Requirements in Order No. R4-2002-0028 are no longer necessary and may be terminated.
5. The Los Angeles Water Board has notified the Discharger, interested agencies, and persons of its intent to consider termination of the Water Recycling Requirements and has provided them with an opportunity to submit written comments.
6. The Los Angeles Water Board, in a public hearing, heard and considered all comments and testimony pertinent to this matter.

IT IS HEREBY ORDERED that the following water reclamation requirements be terminated, except for enforcement purposes:
