The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will hold a public meeting to consider a tentative order terminating Order No. 94-006, which was adopted on December 20, 1993, for the discharge of treated domestic wastewater from the San Nicolas Island Wastewater Treatment Plant.
