NOTICE OF OPPORTUNITY FOR PUBLIC COMMENTS AND HEARING ON TERMINATION OF WASTE DISCHARGE REQUIREMENTS FOR SURFACE IMPOUNDMENT – H. KRAMER & COMPANY and HARSHAW CHEMICAL COMPANY AND ITS SUCCESSOR COMPANIES, 1 CHAPMAN WAY, EL SEGUNDO, CALIFORNIA (FILE NO. 92-057, GEOTRACKER ID SL204011483)

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will consider termination of Waste Discharge Requirements (WDRs) Order No. 94-031, adopted by the Los Angeles Water Board on April 4, 1994, for the H. Kramer & Company and Harshaw Chemical Company and its Successor Companies (Dischargers) surface impoundment facility located at 1 Chapman Way, El Segundo, California.

The Regional Water Board meeting is scheduled to consider this matter at its regularly scheduled board meeting on:

Place: 320 West 4th Street, Los Angeles, California, 90013 (Carmel Room). The meeting is currently scheduled to take place in-person with an option for remote participation.

event if any party or the Los Angeles Water Board would be unduly prejudiced by the late submittal including if staff or the Los Angeles Water Board would not have an adequate opportunity to review, consider, and respond to the comments or evidence.
