**TENTATIVE ORDER TO TERMINATE INDIVIDUAL WASTE DISCHARGE REQUIREMENTS ORDER NO. 91-054 FOR SANTIAGO SQUARE SHOPPING CENTER, BUILDING A, LOCATED AT 33302 – 33345 SANTIAGO ROAD, ACTON, CALIFORNIA 93510 (FILE NO. 90-079, ORDER NO. R4-2024-XXXX, CI-7039, GLOBAL ID WDR100000031)**

Dear Brady Watt:

On April 22, 1991, the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) adopted Individual Waste Discharge Requirements (WDRs) Order No. 91-054 and Monitoring Reporting Program (MRP) No. CI-7039 for domestic wastewater discharge from Building A at the Santiago Square Shopping Center located at 33302 - 33345 Santiago Road, Acton, California 93510.

On May 7, 2024, Watt Enterprises, Ltd. (Discharger) was authorized to discharge domestic wastewater from the Santiago Square Shopping Center (Buildings A, C, D, E, and a gym) under General WDRs Order WQ 2014-0153-DWQ (Series No. 063) and MRP No. CI-10761.

Enclosed is the tentative Order to terminate Individual WDRs Order No. 91-054 and MRP No. CI-7039. The tentative Order is also available at the [Los Angeles Water Board's website](https://www.waterboards.ca.gov/losangeles).

The Los Angeles Water Board hereby requests comments on the proposed termination of WDRs. In accordance with administrative procedures, the Los Angeles Water Board is scheduled to consider the enclosed tentative termination Order and public comments timely received at a public hearing to be held at **9:00 a.m. on September 26, 2024, at the United Water Conservation District (UWCD, 1701 N. Lombard Street, Oxnard California 93030)**. A virtual platform is also available for those who would like to join the meeting online. Please follow the directions provided in the agenda to register or view the Board meeting online. The Los Angeles Water Board will hear any testimony pertinent to this discharge and the tentative termination Order. It is expected that the Los Angeles Water Board will take action at the hearing; however, the Los Angeles Water Board, at its discretion, may order further investigation if the testimony at the meeting warrants it.

In order to be reviewed by Los Angeles Water Board staff and included in the Los Angeles Water Board members' agenda packets, written comments or evidence regarding this tentative termination Order must be received by the Los Angeles Water Board by 5:00 p.m. on **August 30, 2024**. Failure to comply with these requirements is grounds for the Los Angeles Water Board to refuse to admit the proposed written comments into the record. Timely submittal of written comments is required to ensure that all comments are accurately and fully included in the administrative record, that Los Angeles Water Board staff is able to provide timely review and prepare response to comments, and that Los Angeles Water Board members have sufficient time to give full consideration of the comments and issues raised.
