Issuance of Administrative Civil Liability Complaint No. R4-2023-0007 to the City of Los Angeles for the Hyperion Treatment Plant

On March 29, 2023, the Los Angeles Water Board Assistant Executive officer issued Administrative Civil Liability Complaint No. R4-2023-0007 (Complaint) against the City of Los Angeles (City) to address the July 2021 Incident at the City's Hyperion Treatment Plant (Hyperion), during which over 12 million gallons of raw sewage were discharged from Hyperion into the Pacific Ocean. The Complaint alleges five violations, including the unauthorized discharge of raw sewage from Hyperion on July 11 and 12, 2021, subsequent monitoring and reporting violations of the Los Angeles Water Board's California Water Code Section 13383 Order, and other violations of Hyperion's NPDES permit requirements, including effluent limitations, monitoring and reporting requirements, and a permit prohibition relating to odor. The Complaint proposes \$21.7 million in administrative civil liability against the City. On April 4, 2023, the City submitted a signed waiver to waive the 90-day hearing requirements, and the City and the Los Angeles Water Board Prosecution Team have agreed to enter into settlement discussions. The Prosecution Team will work with the City to provide a joint settlement update to the Board in three months.

Remediation Sections I and II

Update on the Former Kast Property Tank Farm, Carousel Tract Residential Neighborhood, Carson

Activities related to site investigation and cleanup work performed in February 2023 include the following:

- 1. Cleanup of 270 (~95%) out of 285 properties have been completed.
- 2. On February 15, 2023, the Los Angeles Water Board received a document titled Fourth Quarter 2022 Remediation Progress Report. The report summarizes the activities related to the remediation conducted from October to December 2022 such as monitoring of groundwater, light non-aqueous phase liquid (LNAPL) recovery and sub-slab soil vapor probe sampling; the outreach conducted with residents in Clusters 22, 23, and 24; and the remediation activities including the excavation and soil vapor extraction system (SVE) installation progress.
- 3. On February 15, 2023, the Los Angeles Water Board received a document titled Fourth Quarter 2022 Soil Vapor Extraction System Quarterly Monitoring Report. The report summarizes the activities relating to the SVE/bioventing system currently operating at 24418 S. Main Street, Suite 401/402, at the former Kast Property from October 1 through December 31, 2022. During the Fourth Quarter 2022, the zone along Ravenna Avenue, E. 248th Street, and a portion of E. 244th Street began operation, and the zone along Marbella Avenue and the western half of E. 244th Street continued operation. The next phase of the SVE system (zone along Neptune Avenue and E. 249th Street) will begin operating in the first quarter of 2023.

Former Athens Tank Farm / Ujima Village Apartments and Ervin Magic Johnson Regional Park (EMJRP), Los Angeles

Activities related to the environmental site investigation of the Former Athens Tank Farm conducted in February 2023 are summarized below:

- 1. Recent and ongoing activities for the former Athens Tank Farm site are as follows:
 - a. Phase I and Phase II Soil Vapor Extraction (SVE) Systems:
 - i. Laboratory results showed Phase II SVE effluent concentrations exceeded permit limits in December 2022. Following receipt of the laboratory report, a second effluent sample was collected and submitted for rapid analysis. Results showed the system was in compliance.
 - ii. SVE remediation wells SVE-04 and SVE-05 were inaccessible in the fourth quarter 2022 since this area was fenced off by the Ujima Housing Corporation (UHC). Access negotiations with UHC are ongoing and the wells will be sampled during the following scheduled sampling event once access has been granted; and

iii. As of December 1, 2022, approximately 710,656 pounds of VOCs and 128,920 pounds of methane have been removed from both the Phase I and Phase II SVE systems.

b. Phase III NAPL Removal Systems

- i. Tiered NAPL Recovery Summary
 - (1) Tier I NAPL Recovery Automated Skimming. Currently operating on wells ATF-19B, ATF-21B and ATF-28B. Total Tier I recovery is 3,051 gallons.
 - (2) Tier II NAPL Recovery Manual Bailing. Conducted on wells ATF-13B and ATF-28B. The total Tier II NAPL recovery is 290.55 gallons.
 - (3) Tier III NAPL Recovery Oleophilic Absorbent Socks. Currently deployed in 11 wells: ATF-5B, -10A, -13B, -22B, -26B, -29B; KLFOB-01, -02; and KLFSVE-01 through -03. A total of 58 absorbent socks have been replaced.

c. Air/Bio-Sparge System

 The air/bio sparge system is operating and collecting system performance data. Approximately 250,803 pounds of VOCs have been removed by sparging as of December 1, 2022.

Update on Smith Service Station in Long Beach

Annual groundwater monitoring was conducted at the site on December 14th and 15th, 2022, by representatives of the Smith Service Station (GeoBlue Consulting). In addition, the State Board, the Regional Board, a consultant for Paramount Pipeline LLC, and a USEPA contractor were present during the field work. Groundwater samples were collected from 19 wells associated with the site over two days. In addition, split samples were collected from selected wells where LNAPL was previously encountered for further chemical fingerprinting analysis. Analytical results were submitted to the Regional Board in January 2023 and indicate LNAPL was detected in six wells, two more than previously detected. A report of the Chemical Fingerprinting Analysis that was conducted by the contractor for USEPA has been recently submitted and is currently being reviewed by Regional Board staff. A Path-to-Closure meeting has been scheduled for early April with the State Board and the Responsible Party.

Commercial, Industrial, and Institutional (CII) Stormwater Program Update

The due date for written comments on the tentative General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Commercial, Industrial, and Institutional (CII) Facilities in the Dominguez Channel/Greater Los Angeles and Long Beach Harbor Watershed and the Los Cerritos Channel/Alamitos Bay Watershed was October 24, 2022. The CII Unit received a total of thirty-three written comment letters representing various interests including environmental organizations, municipalities, watershed management groups, various commercial companies, industry coalitions and consulting firms. The CII Unit is working on a response to the written comments. CII staff continues to coordinate with USEPA on any comments on the designation memo that may require revision of the draft CII permit. On February 7 and February 21, 2023, CII staff met a with Dominguez Channel Watershed Management Group representative and consultant to continue discussions on a transparent and equitable fee level structure for potential CII permittees who choose to comply with the CII Permit through funding contribution to regional stormwater projects.

SB1215 Program Update

The Senate Bill 1215 (SB 1215) Wastewater Consolidation (WWC) Program staff continue to work closely with the State Water Board Division of Financial Assistance (DFA), public sewer service providers (SSPs), and a Technical Service Provider (TSP), RCAC, to facilitate septic to sewer system conversion in priority disadvantaged/severely disadvantaged communities within the Los Angeles Region within Region 4.

On February 28, 2023, staff participated in a joint Teams meeting with DFA, LA Sanitation, and RCAC representatives on the Tujunga/Marcus Septic-to-Sewer Project. This project will consist of about 80 to 100 service connections and construction of approximately 3,000 feet of sewer line. LA Sanitation currently has no funding for the Tujunga/Marcus Project and will need to rely on grant funding from DFA. This project is one of the 16 fundable projects in the region on DFA's list. However, the City indicated they are not ready to move forward with the application for funding due constraints on working on private properties for private lateral connections, which are necessary for a complete application. Additionally, LA Sanitation stated that front money is needed to develop and implement a mini-grant program for the residents.

Integrated Report

The federal Clean Water Act requires that California report on the quality of its surface waterbodies every two years. In order to meet this requirement, California develops the Integrated Report. The Integrated Report consists of the Clean Water Act section 303(d) list of impaired waters and section 305(b) condition report. To develop the Integrated Report, data from California surface waters are assessed to determine if they contain pollutants at levels that exceed water quality standards.

The Water Boards assess waters from three Regional Boards every two years. The 2024 303(d) list, currently in development, includes the San Francisco Bay, Santa Ana, and Los Angeles Regional Boards. Los Angeles Water Board staff are working closely with State Water Board staff to assess the waters in the Los Angeles Region.

A draft 2024 Integrated Report, including the draft 303(d) list, was released for public comment on February 16, 2024. On March 21, 2023, the State Water Board held a workshop on the draft 2024 list to hear initial feedback. The public comment period closed on April 3, 2024. Staff anticipate that a revised Integrated Report and response to comments will be complete in late 2023 and the State Water Board will consider approval of the Integrated Report in late 2023 or early 2024.

Watershed Regulatory Section

Updates to the Region's Recycled Water Projects

At the November 2022 Board Meeting, representatives from the Los Angeles Sanitation and Environment (LASAN), Los Angeles Department of Water and Power (LADWP), Los Angeles County Sanitation Districts (LACSD), Metropolitan District of Southern California (MWD) and Las Virgenes Municipal Water District (LVMWD) presented their agencies' various indirect and direct potable reuse projects in the Region. Collectively, these projects are expected to deliver 54%(432,000 AFY out of 800,000 of the 2030 goal) of *California's Water Supply Strategy* recycled water goals for 2030.

Since November, **LASAN's Hyperion 2035 Project** is in the process of commencing startup of its Hyperion Advanced Water Purification Facility (AWPF) and Membrane Bioreactor (MBR) Pilot Study. The Hyperion AWPF is anticipated to start in early 2024. In January 2023, LASAN hosted a workshop to seek the advisory panel's input on Hyperion's wet weather flows, which will be used to optimize the program's schedule and cost of delivery.

For the **Pure Water Southern California (PWSC) Program**, MWD provided a Notice of Intent to prepare a draft environmental impact report (EIR) for the program. PWSC is a joint partnership between MWD and LACSD which will produce up to 150 million gallons per day of purified water for indirect and direct potable reuse by 2032. The public commenting period ended last year and a draft EIR is expected to be released in 2024. MWD and LACSD are also continuing to collect data on the secondary and tertiary MBR systems to evaluate their respective efficacy and to optimize the program's final design.

On March 22-23, Watershed Regulatory Section staff participated in the Independent Science Advisory Panel Workshop for the PWSC Program. During the two-day workshop, MWD and LACSD provided preliminary results for the secondary- and tertiary membrane bioreactor (sMBR and tMBR, respectively) pilot studies. The advisory panel is expected to issue a report within the next month, which will provide feedback on the preliminary results and assist the project sponsors in their decision-making processes.

For the **Las Virgenes Pure Water Project**, in December 2022, the Las Virgenes-Triunfo Joint Powers Authority certified the Final Programmatic Environmental Impact Report and selected the preferred location of its AWPF to be constructed in Agoura Hills. In January 2023, the Las Virgenes-Triunfo was awarded \$10.2 million in grants from the United States Bureau of Reclamation's Title XVI Water Reclamation and Reuse Program.

Financial Assistance

In February and March, Watershed Regulatory Section staff assisted two Clean Water State Revolving Fund (SRF) applicants in improving project applications within the region. The SRF is a federal and state partnership that provides low-rate financing and grants to projects to support statewide and regional water quality goals. In February, staff met with the Los Angeles County Department of Public Works, whom are the project proponents of the Malibu Mesa Water Reclamation Plan Refurbishment Project and was able to improve the County's application to make their application more competitive for the FY 2023-2024 funding round. The Malibu Mesa

Refurbishment Project will assist the plant in complying with the ammonia nitrogen effluent limitations. In addition, on March 13, staff met with LVMWD staff to help improve their application for the Pure Water Project. The Pure Water Project will augment and produce 2,100 acre-feet per year of local, potable water for the residents and will also help LVMWD comply with its NPDES permit requirements to reduce excessive nutrients in the Malibu Creek watershed.
