#### Remediation Section

Former Kast Property Tank Farm, Carousel Tract Residential Neighborhood, Carson Dr. Teklewold Ayalew, (213) 576-6739 Site Cleanup Unit III

The activities related to the site investigation and cleanup work performed during the month of April 2020 include the following:

On April 2, 2020, Shell notified the Regional Board of its intent to re-start work on April 6, 2020 following a thorough review of the new health and safety-related guidelines that were issued in response to the COVID-19 pandemic. On April 6, 2020, Shell contractors resumed work with a small crew performing restoration on Cluster 14 homes.

- On April 10, 2020, Regional Board staff received a document titled First Quarter 2020 Remediation Progress Report for the former Kast Property. The Report summarizes remedial actions implemented including related testing, monitoring, property-specific remediation plans for Clusters 14 and 15, outreach activities, and a list of activities planned for the Second Quarter 2020.
- On April 14 and 29, 2020, the Regional Board received a document titled Sub-Slab Soil Vapor Monitoring Report (three reports). The reports present the results of sub-slab soil vapor sampling at 24633 Marbella Avenue, 24743 Ravenna Avenue, and 24716 Ravenna Avenue. Regional Board is currently reviewing the reports.
- 3. On April 29, 2020, during remedial excavation activity on Cluster 15 properties, a mobile non-aqueous phase liquid (NAPL) was observed creating a sheen on the northern sidewall of the 10-foot excavation in the front yard of 24627 Marbella Avenue. Per the existing remedial excavation procedure, the 10-foot excavation was backfilled to 5 feet below ground surface with slurry (controlled low-strength material [CLSM]) on the same day. This area is approximately 15-20 feet west of Well MW-3, which contains approximately 5-6 feet of NAPL.
- 4. As of April 30, 2020, the status of the implementation of the cleanup at the Carousel Tract properties are as follows:
  - a. Completed cleanup of 147 (~52 %) properties / homes.
  - b. Completed remediation work and near completion of restoration phase: landscaping and hardscaping work at Cluster 14.
  - c. SVE header trenching and pipe installation were completed along Marbella Avenue.
  - d. Excavation and backfill, SSD system installation, SVE well and piping installation, and utility restoration are in progress at Cluster 15; and
  - e. Performed semi-annual street soil vapor monitoring, monthly LNAPL removal,

and semi-annual groundwater monitoring events.

Former Athens Tank Farm / Ujima Village Apartments and Ervin Magic Johnson Regional Park (EMJRP), Los Angeles Dr. Teklewold Ayalew, (213) 576-6739 Site Cleanup Unit III

The activities related to the environmental site investigation of the Former Athens Tank Farm during the month of April 2020 are summarized as follows:

- 1. On April 10, 2020, the Regional Board received a document titled First Quarter 2010 Phase I/II Soil Vapor Extraction Remedial Progress Report. To date, the Phase I/II treatment system has removed an estimated 593,035 pounds of volatile organic compounds (VOC-hexane equivalent) and 90,219 pounds of methane. Phase I Soil Vapor Extraction Rebound Evaluation was conducted and the Phase I SVE system recovery has reached asymptotic conditions in all SVE wells. The report proposed the discontinuation of the Phase I SVE system. The Phase II Horizontal Remediation Well SVE System was installed in 2017and started full-time operation on March 26, 2019.
- 2. On April 10, 2020, the Regional Board received a document titled First Quarter 2020 Phase III Groundwater Remedial Progress Report. This report presents the results of quarterly groundwater remedial progress conducted at the site. An increasing trend in dissolved oxygen occurred for the first few quarters after startup in each of the four sparge observation wells. During the past few quarters, elevated dissolved oxygen concentrations in these wells have been variable, suggesting increased consumption by microbes of the supplied dissolved oxygen. The overall trend in dissolved benzene concentration in groundwater samples from observation wells is decreasing in the wells near the treatment zone. The estimated cumulative mass of VOCs as hexane removed is 143,270 pounds. In addition, the estimated cumulative Non-Aqueous Phase Liquid (NAPL) recovery was 791 gallons using targeted automated skimming and 287 gallons with manual bailing.
- 3. On April 10, 2020, the Regional Board received a document titled *Quarterly Soil Gas Monitoring Report First Quarter 2020*. During this monitoring event probes with historically low concentrations or no detection of methane continued to show low concentrations to no detections, while probes with historically higher concentrations of methane continued to show elevated concentrations. Probes previously showing low concentrations or no detection of benzene continued to show low concentrations to no detections.
- 4. The following is a summary of the redevelopment activities conducted by the County of Los Angeles:
  - a. Phase 1A redevelopment activities are currently scheduled to be completed by July 2020.

- b. The 90% complete plans for the Phase 1B redevelopment in the former Ujima Village Apartments (UVA) were received.
- c. On April 29, 2020, an Exxon representative and consultants led a site walk for LA County representatives and contractors bidding on Phase 1B redevelopment within the former UVA.
- d. Bids for Phase 1B construction were due to Exxon on May 20, 2020, with contracts anticipated to be awarded in June 2020; and
- e. Construction activities are anticipated to start in June/July 2020 and will continue until early/mid-2021.
- 1. The following is a summary of completed, ongoing and upcoming cleanup activities for the site:
  - a. Phase II SVE system:
    - (1) System performance monitoring is scheduled to be performed in May 2020.
    - (2) The system has been running since February 27, 2020, following completion of repairs; and
    - (3) As of February 27, 2020, approximately 593,035 pounds of VOCs and 90,219 pounds of methane have been removed from both SVE systems.

#### b. Phase III: Groundwater:

- (1) The Non-Aqueous Phase Liquid (NAPL) Recovery Trailer, previously operating on wells ATF-19B and ATF-21B, is now currently recovering from ATF-28B.
- (2) Operation of the Air/Bio sparge system and collection of system performance data continues.
- (3) System performance monitoring is scheduled to be performed in May 2020.
- (4) System data acquisition scheduled to be completed in May 2020; and
- (5) The NAPL trailer recovered approximately 364 gallons of NAPL during the first quarter of 2020.
