Monthly update on COVID requests for Relief from Water Board requirements.

Although the number of new requests has slowed, we continue to receive them from the regulated community seeking relief from permit and other regulatory requirements during the COVID pandemic.

Every request is tracked, including when it was received and the status of the Region's response. All requests receive an email from staff acknowledging receipt of the request and ask for more information if needed. Each request is evaluated, and a response generated providing our assessment for relief based primarily on the expected effect of the proposed action on human health. Recommendations include extend or suspend requirements, extend comment due dates, delay Regional Board action; or deny the request.

Region 4 received 4 requests in March bringing the total to 191. In total, we issued 152 responses, of which 121 requests were approved, 31 were denied with none pending review. It is important to note that 39 of the requests were withdrawn, meaning the requestor was able to comply with the requirement in a timely manner.

Remediation Section

Former Kast Property Tank Farm, Carousel Tract Residential Neighborhood, Carson - Dr. Teklewold Ayalew, (213) 576-6739 Site Cleanup Unit III

Activities related to site investigation and cleanup work performed during March 2021 include the following:

- 1. On March 22, 2021, the Regional Board received reports summarizing results of subslab soil vapor sampling at 378 East 249th Street, 24416 Ravenna Avenue, 24423 Neptune Avenue, and 24823 and 24833 Panama Avenue. Sub-slab depressurization (SSD) systems are required for three of the five properties: 378 E. 249th Street; 24416 Ravenna Avenue; and 24423 Neptune Avenue. Sampling of the sub-slab soil vapor probes will continue at these properties until the constituents of concern (COC) detected are below the sub-slab soil vapor site-specific cleanup goals (SSCGs) for two consecutive sampling events following SSD system startup. Per RDIP Addendum No. 3, long-term sub-slab soil vapor sampling at 24823 Panama Avenue can be terminated because there have been four consecutive sampling rounds for at least two probes in which detected COC concentrations were below sub-slab soil vapor SSCGs. Sampling of the sub-slab soil vapor probes at 24833 Panama Avenue will continue every other year until there have been four consecutive sampling rounds for at least two probes in which detected COC concentrations are below sub-slab soil vapor SSCGs.
- 2. Cleanup of 171 (~60%) properties / homes is complete. All work is proceeding on schedule. The status of cleanup implementation at the Carousel Tract is as follows:

Clusters 16

- a. All homes are undergoing landscape and hardscape restoration, including installation of concrete surfaces for driveways, walkways, and patios, and decorative walls for courtyards.
- b. Each homeowner has been called to schedule two separate appointments in the upcoming weeks: one for installation of gas meters the week of March 29th and another for a post-construction inspection the week of April 5th.
- c. Work is on track to be completed by Friday, April 9th at 5 PM. Move back is scheduled for the week of April 12th.

Cluster 17

- a. All excavation and backfilling work are complete; and
- b. Installation of remediation systems in progress drilling of wells for Soil Vapor Extraction, Sub-Slab Depressurization and restoration of utilities.

Former Athens Tank Farm / Ujima Village Apartments and Earvin Magic Johnson Regional Park (EMJRP), Los Angeles - Dr. Teklewold Ayalew, (213) 576-6739 Site Cleanup Unit III

Activities related to environmental site investigation of the Former Athens Tank Farm during March 2021 are summarized below:

- 1. On February 25, 2021, ExxonMobil Consultants (Kleinfelder) met with the County of Los Angeles Engineering staff and discussed the status of grading and construction around groundwater monitoring well ATF-4B.
- 2. Kleinfelder and ExxonMobil met on-site with Los Angeles County Parks and Recreation and Los Angeles County's outside architect to discuss redevelopment of the sports fields, and the area south of the remediation compound.
- 3. A summary of completed, ongoing and upcoming activities for the former Athens Tank Farm site are as follows:

Phase I Soil Vapor Extraction (SVE)

a. Wells SVE-02 and SVE-11 have been connected to the Phase II SVE system.

Phase II SVE

- a. The system is operating and currently extracting from wells HRW-203 (all 3 screens), HRW-205 (all 3 screens), HRW-207 (all 3 screens) and from Phase I wells SVE-02 and SVE-11. Extraction from HRW-204 and HRW-206 have been temporarily suspended due to loss of vacuum in these lines.
- b. As of February 28, 2021, approximately 618,278 pounds of VOCs and 97,195 pounds of methane have been removed from both SVE systems.

Phase III Systems

NAPL Recovery Trailer

- a. The NAPL Recovery Trailer is currently operating on wells ATF-19B, ATF-21B and ATF-28B;
- b. As of February 28, 2021, the NAPL Tier 1 cumulative removal using the NAPL Recovery Trailer is 1,615 gallons and NAPL Tier II cumulative recovery using manual bailing is 288 gallons.

Air/Bio-Sparge System

a. The system is operating and collecting system performance data.

Consent Judgment - Coast United Advertising, d/b/a Coast United Property Management

The Regional Board entered into a consent judgment settling a lawsuit to enforce a Cleanup and Abatement Order (CAO) against Coast United Advertising, d/b/a Coast United Property Management (Coast United) on April 21, 2021. Although the consent judgment still needs to be entered by the Court, we expect it will be done so within the next month by stipulation. As a result of the lawsuit, the property owner, Coast United, will have to fully delineate and clean up a plume of volatile organic compounds (VOCs) including trichloroethylene (TCE), among others, and continue mitigating for vapor intrusion into nearby homes and businesses. This consent judgment is one of the first of its kind, ensuring that Coast United paid penalties up front to fund a supplement environmental project or SEP; payment of full oversight costs to the Regional Board; and it has suspended penalties of approximately \$4.2 million pegged to cleanup tasks as set forth in the CAO. Once a task is completed fully to the Regional Board's satisfaction, a percentage of the penalties will be suspended. The Regional Board hopes this consent judgment will be a model for future CAO enforcement.

TMDL Program

Staff is working on a bacteria TMDL for the Los Cerritos Channel and Estuary and the Alamitos Bay-Colorado Lagoon. Staff is finalizing the proposed draft TMDL and associated draft documents to present to the Board for consideration in the fall.

A groundwater study, funded by discretionary contract funds, to determine the impact of on-site wastewater treatment systems (OWTS) on the Santa Clara River Lakes was successfully completed on time by April 15. The contract was executed by the US Geological Survey, which included drilling groundwater monitoring wells, collecting groundwater data, and providing staff with documentation to be used for setting up and calibrating a groundwater model by the Regional Water Board staff.

Staff continues to participate in the bi-weekly meetings for the development of the *Ventura River Watershed Groundwater-Surface Water and Nutrient Transport Models*. There will be a series of three webinars coming up in May and June, where the State Board and Regional Water Board staff as well as the consultants in charge of this project will give joint presentations on the model development.

Watershed Regulatory Section

Regional Water Board staff in the Watershed Regulatory Section attended the virtual WateReuse Symposium that was held throughout the month of March. The symposium focused on showcasing the important role that water recycling plays in ensuring water security, safety, and supply. Staff viewed recorded presentations and live roundtable discussions on topics including water recycling as a public health and resiliency strategy, regional approaches to water recycling, treatment approaches and emerging trends in recycled water used for drinking water, and implementation and operation of decentralized and centralized water recycling systems. The information provided at the symposium will be instrumental to staff when developing recycled water permits throughout the Los Angeles Region.

Staff also attended the virtual Statewide Advisory Committee on Cooling Water Intake Structures (SACCWIS) Annual Meeting. The purpose of the meeting was to consider approval of the Draft SACCWIS Report, which contains a recommendation to extend the Once-Through Cooling Policy compliance date for Redondo Beach Generating Station until December 31, 2023 to respond to system-wide grid reliability concerns. At the meeting, SACCWIS also heard comments from stakeholders, interested parties, and the public on the draft SACCWIS Report and recommendation regarding the Redondo Beach Generating Station. After a presentation on the draft SACCWIS Report and public comments, SACCWIS approved the report. The next step will be for the State Water Board to consider amending the OTC Policy to extend the compliance deadline for Redondo Beach Generating Station as recommended by SACCWIS, which is anticipated to take place later this year.
