#### Monthly update on COVID requests for Relief from Water Board requirements

Although the number of new requests has slowed, we continue to receive them from the regulated community seeking relief from permit and other regulatory requirements during the COVID pandemic.

Every request is tracked, including when it was received and the status of the Region's response. All requests receive an email from staff acknowledging receipt of the request and ask for more information if needed. Each request is evaluated, and a response generated providing our assessment for relief based primarily on the expected effect of the proposed action on human health. Recommendations include extend or suspend requirements, extend comment due dates, delay Regional Water Board action; or deny the request.

Region 4 received 2 requests in February bringing the total to 189. In total, we issued 148 responses, of which 118 requests were approved, 30 were denied and 3 are currently under evaluation. It is important to note that 38 of the requests were withdrawn, meaning the requestor was able to comply with the requirement in a timely manner.

#### Virtual Inspection at Ojai Valley Wastewater Treatment Plant

On February 23, 2021, Enforcement I Unit staff conducted a routine compliance inspection virtually at the Ojai Valley Sanitary District's Ojai Valley Wastewater Treatment Plant (OVWWTP). Los Angeles Regional Water Board Chair Lawrence Yee, Board

Member Jim Stahl, and the Regional Water Board Executive Management team also participated in the facility tour portion of the virtual inspection. Since May 2020, the Enforcement I Unit began using virtual inspections, where appropriate, as an alternative measure in carrying out our essential functions, while minimizing COVID-19 exposure risks for staff or the regulated community that might otherwise be present during an inperson inspection. The virtual inspection at OVWWTP was conducted via a WebEx conference set up by the Ojai Valley Sanitary District.

#### Industrial Sites Task Force and SB 205 Update – Meeting

On March 1, 2021, an Industrial Sites Task Force meeting was held via Zoom, with members representing municipal government, industry, and non-governmental organizations, along with Regional Water Board Member Irma Muñoz and Regional Water Board Staff. Regional Water Board Chair Lawrence Yee, Vice Chair Cynthia Guzmán, State Board Member Sean Maguire, Region 8 Assistant Executive Officer Jayne Joy were also in attendance.

Mr. Terry Adams of SA Recycling gave a presentation about how various SA Recycling facilities in the Los Angeles Region were implementing measures to comply with TMDL requirements in the statewide General Permit for Storm Water Discharges Associated with Industrial Activities (commonly referred to as the IGP). SA Recycling currently has 17 facilities enrolled in the IGP in the Los Angeles Region. Of these, five facilities have implemented advanced BMPs (i.e., stormwater capture and treatment systems). They are also looking into the potential to use capture and infiltration BMPs for their other facilities within the Los Angeles River watershed.

Regional Water Board Unit Chief Nerissa Schrader gave an update on the status of the Regional Water Board's implementation and outreach activities to cities and counties related to Senate Bill 205 (SB 205). These activities included conducting four workshops: two in November 2020, one in January 2021, and one in February 2021. There were 134 attendees from 54 cities and counties present. The objectives of the workshop were to assist governmental entities with current business licensing programs, clarify the SB 205 requirements, assist with implementation, and answer questions. Designated Regional and State Water Board contacts were provided to the cities and counties. Ms. Schrader also pointed out that from January 2020 to date, an increase of over 500% in Industrial General Permit applications have been observed, though non-filer businesses may still exist from cities and counties that have no business licensing programs (where SB 205 is not applicable). Santa Fe Springs, Vernon, Oxnard, and the Gateway and South Bay cities have had the largest increases in permit applications.

The next Industrial Sites Task Force meeting is tentatively scheduled for June 2021.

### **Remediation Section**

#### Former Kast Property Tank Farm, Carousel Tract Residential Neighborhood, Carson - Dr. Teklewold Ayalew, (213) 576-6739 Site Cleanup Unit III

Activities related to site investigation and cleanup work performed during February 2021 include the following:

- 1. On February 5, 2021, the Regional Water Board received a document titled Procedure for Addressing Pipelines Encountered in Excavations, Former Kast Property Remedial Action Plan Implementation Project, Carson, California (Revised February 5, 2021) (Pipeline Procedure). The document outlines procedures to be followed if previously unknown pipelines or pipeline remnants are encountered during remedial excavation work at the Site. The initial pipeline removal memorandum dated September 12, 2018, addressed only 2-inch and 4-inch pipelines encountered in excavated properties within Cluster 9. The Revised Pipeline Procedure addresses pipelines of a larger diameter encountered within Cluster 17 in the southwest corner of the site. The Regional Water Board agreed with the proposed pipeline removal procedure and on February 16, 2021 issued a letter, approving the procedure.
- 2. On Saturday, February 13, 2021, Regional Water Board staff hosted a virtual Information Tabling Event for the Carousel community. Six residents from both upcoming and completed clusters participated in the event. Residents' main questions were about their cluster cleanup schedule, what remediation activities would be implemented on their properties, and what to expect from their temporary housing. We also had a resident whose property has been cleaned up who wanted to share their positive experiences with the process.
- 3. Cleanup of 171 (~60%) properties / homes has been completed. All work is proceeding on schedule. As of February 28, 2021, the status of cleanup implementation at the Carousel Tract is as follows:

#### Clusters 16

- a. Excavation and installation of remediation systems are complete;
- b. Installation of drainage pipes for rainwater, pouring concrete for driveways, walkways, and patios are in progress; and
- c. Work is expected to be completed by April 9, 2021.

#### Cluster 17

- a. Excavation and backfilling are underway (95% complete); and
- b. Installation of soil vapor extraction wells, sub-slab depressurization and restoration of utilities are in progress.

#### Former Athens Tank Farm / Ujima Village Apartments and Ervin Magic Johnson Regional Park (EMJRP), Los Angeles - Dr. Teklewold Ayalew, (213) 576-6739 Site Cleanup Unit III

Activities related to environmental site investigation of the Former Athens Tank Farm during February 2021 are summarized below:

- 1. On February 25, 2021, ExxonMobil's consultant, Kleinfelder, met with County of Los Angeles Engineering staff and discussed the location and status of grading and construction around groundwater monitoring well ATF-4B.
- 2. Kleinfelder and ExxonMobil meet on-site with Los Angeles County Parks and Recreation and Los Angeles County's outside architect to discuss redevelopment of the sports fields, and area south of the remediation compound.
- 3. A summary of completed, ongoing and upcoming activities for the former Athens Tank Farm site follows:

#### Phase I Soil Vapor Extraction (SVE)

a. Wells SVE-02 and SVE-11 have been connected to the Phase II SVE system.

#### Phase II SVE

- a. The system is operating and currently extracting from wells HRW-203 (all 3 screens), HRW-204 (screens A and B), HRW-205 (all 3 screens), HRW-206 (screens B and C), and from Phase I wells SVE-02 and SVE-11.
- b. The Phase II SVE system continues to run intermittently while waiting for a temperature controller component to be delivered.

#### Phase III Systems

#### NAPL Recovery Trailer

- a. The NAPL Recovery Trailer is currently operating on wells ATF-19B, ATF-21B and ATF-28B;
- b. The NAPL Trailer is currently positioned over well ATF-21B;

#### <u>Air/Bio-Sparge System</u>

a. The system is operating and collecting system performance data.

#### USEPA GRANT FOR SITE CLEANUP PROGRAM

In January 2021, USEPA provided \$50,000 in grant funds to the Regional Water Board via an interagency agreement with DTSC to investigate sources of groundwater contamination that are impacting drinking water wells. The grant funds Regional Water Board staff's review of preliminary assessment reports prepared by and/or on behalf of USEPA and/or DTSC, groundwater data, and historical local agency records in search of potentially responsible parties in the Central Basin and the Pomona Basin. The grant also funds staff's drafting of orders for site assessment and remediation. This funding will not be used for any tasks in the San Fernando Basin, for which the Regional Water Board has separate funding from USEPA and from LADWP.

#### Prop 1 Update

The Division of Financial Assistance (DFA) has awarded a total of \$280 million in Prop 1 grant funds to the Los Angeles Department of Water and Power (LADWP) for three projects in the San Fernando Basin that will treat contaminated groundwater to supply drinking water. Treatment at all three well fields will consist of ultraviolet light and hydrogen peroxide (together, Advanced Oxidation Process) and granular activated carbon (GAC) to remove chlorinated solvents and 1,4-dioxane. Construction of the North Hollywood West Remediation Project is 85% complete. LADWP has completed 100% design plans and broke ground on the Tujunga Well Field Remediation Project and the North Hollywood Central Remediation Project in November 2020.

#### Pneumo Abex Site

Site investigation and cleanup activities at the Former Abex Aerospace Facility located at 3151 West 5<sup>th</sup> Street, Oxnard, California (Site) are being conducted under Cleanup and Abatement Order No. 95-021 (Order) originally dated February 9, 1995. Between 1960 and 1993, Pneumo Abex, LLC and its predecessor, Abex Aerospace Corporation (Abex), operated a manufacturing facility for the development of aerospace components. During its manufacturing operations, the facility stored chemicals, including chlorinated solvents containing volatile organic compounds (VOCs) and petroleum hydrocarbons in underground storage tanks (USTs) for use. The facility ceased in 1993.

As part of the ongoing investigation, off-site soil vapor probe installation and the first round of field sampling in the residential area south of the site was conducted from January 20, 2021 to February 19, 2021. Prior to starting the field work, a work notice (i.e., including what, why, where, and when the sampling will be conducted) was sent to the residents and businesses in the area, and interested parties. Currently, the responsible parties and consultants are reviewing and evaluating the data collected. A report presenting the results of the first round of off-site soil vapor investigation will be submitted to the Regional Water Board by April 15, 2021.

The United Technologies (formerly Pratt & Whitney Rocketdyne) Site in Canoga Park completed additional soil vapor site assessment activities in January 2021. A technical report summarizing this data and the next steps is due to the Regional Water Board by April 30, 2021. Regional Water Board staff is continuing to compile and respond to the comments received from the public meeting held in 2020 and during the public comment period for the completion of the soil remediation.

# Updated Underground Storage Tank (UST) Program General Analytical Laboratory Guidance

In March 2021, the UST Program Laboratory Guidance was updated to include new components in the State's Low-Threat Underground Storage Tank Case Closure Policy and updates in methodological advancements. This update is a result of work with the State Water Board's Environmental Laboratory Accreditation Program (ELAP) staff and commercial laboratory personnel. The draft version was also discussed with State Water Board UST Cleanup Fund and Water Quality staff as well as at the Certified Unified Program Agency Technical Advisory Group (CUPA TAG) meeting. # *Waste Discharge Requirements (WDR) Issued to Underground Storage Tank Cleanup Sites*

The Regional Water Board Executive Officer has issued enrollment letters for coverage under the Regional Water Board's General Waste Discharge Requirements for in-situ treatment of groundwater at the following UST impacted sites: (1) Tosco Station #5939, 76 Termino (enrolled on 07/2020); (2) Mobil Station #18-LR4, 501 Las Posas (enrolled on 09/2020); (3) Unocal #5021,1345 Pacific Coastal Hwy. (enrolled on 10/2020); (4) Former Gas-To-Go, 1353 Western (enrolled on 01/2021); and (5) Former Texaco Station,

1196 Los Angeles Avenue (enrolled on 03/2021). One of the advantages of using in-situ treatment for cleanup of contaminated groundwater is to avoid extracting groundwater during the remediation process, which conserves water resources.

#### TMDL Program

TMDL staff is finalizing new bacteria TMDLs for the Los Cerritos Channel and Alamitos Bay-Colorado Lagoon and planning for Board consideration of adoption at the June meeting. The TMDLs will address some bacteria listings that have been included on the 303(d) list of impaired waters since the early 2000s.

#### Irrigated Lands Regulatory Program

A draft conditional waiver of waste discharge requirements for discharges from irrigated agricultural lands was released for public comment on February 18, 2021. The proposed conditional waiver is a limited one-year renewal that carries over the findings and conditions of Order No. R4-2016-0143, previously adopted by the Regional Water Board on April 14, 2016. Ten comment letters were received by the comment deadline on March 4, 2021. Staff is preparing responses to comments and a Board package for Board consideration at the April Board Meeting.

Staff continues to review and provide comments for the water quality management plans and the annual monitoring reports submitted by the Ventura County Agricultural Irrigated Lands Group (VCAILG) and the Nursery Growers Association-Los Angeles County Irrigated Lands Group (NGA-LAILG).

# Watershed Regulatory Section

Regional Water Board staff attended the seventh Technical Advisory Committee meeting for the Los Angeles River Instream Flow Criteria Technical Study on February 26, 2021. During this meeting, staff was provided with a review of the stormwater/storm drain and tidal reach modeling, the process of determining the overall flow recommendations, and the application of the sensitivity curves approach. A draft report including the flow recommendations is expected to be completed and ready for review in March 2021.
