**NOTICE IS HEREBY GIVEN** that the Water Quality Coordinating Committee will provide a Board member field tour of the Sacramento-San Joaquin Delta. A variety of speakers will provide educational presentations on the Sacramento-San Joaquin Delta and the facilities within the Delta. The Water Quality Coordinating Committee consists of the members of the State and Regional Water Boards. A quorum of the individual Boards may be present at the tour stops. The field tour will begin at 8:30 a.m. at the Cal/EPA Building on October 31, 2012. While a quorum of one or more the California Water Boards may be in attendance, there will be no action or voting taking place during the tour. The tour is for educational purposes only.

## INSTRUCTIONS AND ITINERARY FOR TOUR PARTICIPATION

Transportation will be provided for Board Members. Members of the public are invited to participate in the tour but must provide their own transportation. The tour <u>itinerary</u> will include visits to secure facilities that require all entrants to provide a <u>security form</u> should include name, date of birth, and driver's license, State identification or passport number. The facility operators generally require that information several days in advance.

Members of the public are not required to RSVP in order to participate in public meetings. However, due to security restrictions at the individual facilities, any person wishing to participate in the tour will be required to provide identification. Interested persons are strongly encouraged to provide their information in advance to avoid delays on the day of the tour.
