EXECUTIVE ORDER NO. EO-2018-01

AGENT FOR SERVICE OF PROCESS AND PROCEDURE FOR PUBLIC RECORDS ACT REQUESTS

To ensure that subpoenas, summons, complaints, or other legal proceedings against the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board or Board), and requests pursuant to the California Public Records Act (Government Code section 6250 et seq.) are properly served on the Board and routed to the appropriate personnel and timely addressed,

IT IS HEREBY ORDERED AS FOLLOWS:

A. Service of Subpoenas

1. Only the following Los Angeles Water Board positions and personnel are authorized to receive service of a subpoena, including a subpoena duces tecum, for business records, persons most knowledgeable (PMK), the personal appearance by any staff member (in his/her capacity as such), or for any other subpoena directed to the Board (or any of its personnel in their capacity as such):

- 5. Unless identified as an agent, individual staff members are <u>NOT</u> authorized to receive service of a subpoena, <u>even if the individual staff member is identified as the deponent.</u>
- 6. Checks accompanying subpoenas must be made out to "State Water Resources Control Board."
- 7. The Los Angeles Water Board will not accept service of a subpoena involving a matter that is unrelated to Board business.

B. Service of Summons, Complaints, or Other Legal Proceedings

1. Only the following personnel (or their designees) are authorized to receive service of a summons relating to a civil complaint, a petition for writ of mandate, or other legal proceedings against the Los Angeles Water Board:
