I. Order

This Clean Water Act (CWA) section 401 Water Quality Certification action and Order (Order) is issued at the request of Los Angeles World Airports (herein after Permittee) for the Project. This Order is for the purpose described in application submitted by the Permittee. The application was received on October 28, 2016. The application was deemed complete on November 28, 2016.

II. Public Notice

The Los Angeles Water Board provided public notice of the application pursuant to California Code of Regulations, title 23, section 3858 from November 3, 2016 to the effective date of Certification. The Los Angeles Water Board did not receive any comments during the comment period.

III. Project Purpose

The purpose of the project is to remove sediment, debris, and emergent vegetation to restore the ditch capacity, as well as reducing attractiveness to hazardous wildlife, which could potentially cause airplane strike hazards.

IV. Project Description

Los Angeles World Airports (LAWA) Maintenance Services Division (MSD) proposes to perform long-term routine maintenance within Argo Ditch in order to remove sediment and debris and vegetation that attract birds posing aircraft strike hazards. MSD provides vegetation clearance, erosion control, and debris removal 1-2x a year during early February and September/October depending on weather and vegetation conditions. A variety of equipment will be used including excavators, front wheel loaders, skid steer tractors, mowers, and hand carried equipment such as chainsaws and weed whackers.

Argo Ditch is mostly earthen, approximately 9,220 linear feet (If), 30-35 feet (ft) deep, with a channel bottom 12-43 ft wide. The recently constructed Runway 6L-24R Safety Area Improvements and Runway Rehabilitation Project converted 540 ft into a closed concrete box culvert with an additional 40 ft of rip rap (total = 580 lf) (certified under File No. 14-089). Several concrete culverts and side drainages feed into the ditch. Source water is urban runoff, which flows through the open Argo Ditch before passing into a concrete box culvert on the western end. Flows then drain southwest through an underground storm drain system for approximately 0.8 mile before emptying into the Pacific Ocean at Playa Del Rey.

Routine maintenance within Argo Ditch will include the following tasks, as needed:

- 1) Pump standing water from east of bridge to west of bridge.
- 2) Recontour channel bottom as needed to restore flow, minimize excessive pooling and vegetation establishment, and maintain adequate access for maintenance equipment.
- 3) Repair/replace broken concrete inlets and associated riprap and inlet support structures (includes slope stabilization and erosion control measures where needed).
- 4) Maintain 4 permanent access roads (involves adding asphalt concrete (AC) grindings to surface and compacting them into surface with roller). LAWA maintains the access roads

annually by adding approximately 10-20 cubic yards of AC grindings. The ramps are maintained at 12-15 ft width.

5) Vegetation and channel maintenance: LAWA will remove approximately 750 cubic yards of soil and debris per year from the ditch during routine maintenance. The soil and debris that is removed is placed beyond the channel banks near gate 130B on the north side of the ditch. This debris includes waste materials such as bottles and plastic containers deposited in the ditch during rain events as well as vegetation that is removed to prevent the establishment of an airport hazardous wildlife attractant. Vegetation clearance includes removal of trees and large shrubs from the banks using hand carried equipment, and removal of vegetation and regrading of areas where standing water accumulates (typically at 3 outfalls). Work is done when the ditch is dry except near outfalls where there is always ponded runoff water.

A related project, the Argo Drain Sub-Basin Facility is a water diversion facility to be built to treat stormwater flow from the Argo Ditch allowing some of it to percolate in underground infiltration galleries with overflow continuing to the Pacific Ocean. This related project was certified on July 11, 2016 (File No. 16-057).

V. Project Location

Project location is in Los Angeles County at the Los Angeles International Airport. A map showing the Project location is found in Attachment B of this Order.

VI. Project Impact and Receiving Waters Information

The Project is located within the jurisdiction of Los Angeles Regional Water Quality Control Board. Receiving waters and groundwater potentially impacted by this Project are protected in accordance with the applicable water quality control plan (Basin Plan) for the region and other plans and policies which may be accessed online at:

http://www.waterboards.ca.gov/plans policies/. The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the state, water quality objectives to protect those uses, and the state and federal antidegradation policies.

VII. Description of Direct Impacts to Waters of the State

Direct impacts will be removal of sediment and vegetation from the channel which degrade ecological condition.

Based on the LAX Specific Plan Amendment Study Jurisdictional Delineation Waters of the U.S. and State to be impacted include 2.23 acres (5,787 lf) of non-wetland waters and 1.24 acres (3,433 lf) of wetland waters. California Department of Fish and Wildlife (CDFW) impacts include 2.23 acres (5,787 lf) of non-native grassland channel and 1.43 acres (3,433 lf) of freshwater marsh/vegetated riparian habitat.

It is anticipated that the project will remove approximately 750 cubic yards of sediment from the channel during annual maintenance.

Total Project fill/excavation quantities for all impacts are summarized in Table 1. Permanent impacts are categorized as those resulting in a physical loss in area and also those degrading ecological condition only. Earlier permitting of Argo Ditch maintenance required compensatory mitigation for the permanent ecological degradation. Because the permanent degradation of ecological condition was mitigated for by a successful compensatory mitigation project in Ken Malloy Regional Park, these impacts are being accounted for as temporary impacts.

VIII. Avoidance and Minimization

The Permittee has proposed to implement several Best Management Practices, including, but not limited to, the following:

- Sediments shall not be discharged to receiving waters.
- No construction related materials shall be discharged from the project site to receiving waters.

¹ Includes only temporary direct impacts to waters of the state and does not include upland areas of temporary disturbance which could result in a discharge to waters of the state.

- Non-storm water run-off from equipment, vehicle washing, or any other activity shall be contained within the project site.
- Limits of maintenance, grading, and sediment removal activities within the Project footprint will be clearly delineated and minimized to the maximum extent practical.
- Equipment storage, fueling, and staging areas will be located on upland areas. Storm
 water best management practices will be implemented, such as fiber rolls and silt fencing
 as needed, and maintained to prevent runoff from entering the ditch.
- Necessary precautions will be taken to prevent the release of toxic substances into surface waters, such as drip pans, refueling at the designated refueling station in the service yard, and spill response kits in equipment support trucks. Project related spills of hazardous materials will be reported to appropriate entities including, but not limited to, applicable LAWA, USACE, CDFW, and RWQCB authorities, and will be cleaned up immediately and contaminated soils removed and disposed of in approved disposal areas.
- No erodible materials will be deposited into watercourses and loose soil/debris material will not be stockpiled within stream channels or on adjacent banks.
- Work will occur during the dry season or when no rain is forecasted for at least 5 days.

In addition, in order to comply with Section 10 of the Migratory Bird Treaty Act (MBTA) and relevant sections of the California Fish and Game Code (CFGC), any vegetation removal within the Project footprint will take place outside of the typical avian nesting season (typically Feb 15 to Aug 31), or the area cleared by an FAA-qualified biologist prior to vegetation removal during the breeding season.

IX. Compensatory Mitigation

Because previous authorized maintenance was mitigated at a 2.44:1 ratio and the current project includes recurring temporary maintenance impacts to restore the channel design capacity, no additional mitigation is proposed. Temporary impacts will be returned to original design grade..

X. California Environmental Quality Act (CEQA)

The Los Angeles Water Board has determined that the Project is exempt from review under CEQA pursuant to California Water Code of Regulations, title 14, section 15061. Specifically, the issuance of this Order and the activities described herein meet the exemption criteria under California Code of Regulations title 14, section(s) 15302 Replacement and Reconstruction. Additionally, the Los Angeles Water Board concludes that no exceptions to the CEQA exemption apply to the activities approved by this Order.

XI. Petitions for Reconsideration

Any person aggrieved by this action may petition the State Water Board to reconsider this Order in accordance with California Code of Regulations, title 23, section 3867. A petition for reconsideration must be submitted in writing and received within 30 calendar days of the issuance of this Order.

XII. Fees Received

An application fee of \$600 was received on October 28, 2016. Certification is conditioned upon total payment of \$74,682. The fee amount was determined as required by California

Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.

XIII. Conditions

The Los Angeles Water Board has independently reviewed the record of the Project to analyze impacts to water quality and designated beneficial uses within the watershed of the Project. In accordance with this Order, the Permittee may proceed with the Project under the following terms and conditions:

A. Authorization

Impacts to waters of the state shall not exceed quantities shown in Table 1.

B. Reporting and Notification Requirements

The following section details the reporting and notification types and timing of submittals. Requirements for the content of these reporting and notification types are detailed in Attachment C, including specifications for photo and map documentation during the Project. Written reports and notifications must be submitted using the Reporting and Notification Cover Sheet located in Attachment C, which must be signed by the Permittee or an authorized representative.

1. Project Reporting

a. Annual Reporting: The Permittee shall submit an Annual Report each year on the anniversary of Project effective date. Annual reporting shall continue until a Notice of Project Complete Letter is issued to the Permittee.

2. Project Status Notifications

- a. Request for Notice of Completion of Discharges Letter: The Permittee shall submit a Request for Notice of Completion of Discharges Letter following completion of active Project activities, including any required restoration and permitteeresponsible mitigation. This request shall be submitted to the Los Angeles Water Board staff within thirty (30) days following completion of all Project construction activities. Upon acceptance of the request, Los Angeles Water Board staff shall issue a Notice of Completion of Discharges Letter to the Permittee which will end the active discharge period and associated annual fees.
- b. Request for Notice of Project Complete Letter: The Permittee shall submit a Request for Notice of Project Complete Letter when construction and/or any postconstruction monitoring is complete,3 and no further Project activities will occur. This request shall be submitted to Los Angeles Water Board staff within thirty (30) days following completion of all Project activities. Upon approval of the request, the Los Angeles Water Board staff shall issue a Notice of Project Complete Letter to the

Permittee which will end the post discharge monitoring period and associated annual fees.

3. Conditional Notifications and Reports: The following notifications and reports are required as appropriate.

a. Accidental Discharges of Hazardous Materials⁴

Following an accidental discharge of a reportable quantity of a hazardous material, sewage, or an unknown material, the following applies (Wat. Code, § 13271):

- As soon as (A) Permittee has knowledge of the discharge or noncompliance,
 (B) notification is possible, and (C) notification can be provided without substantially impeding cleanup or other emergency measures then:
 - first call 911 (to notify local response agency)
 - then call Office of Emergency Services (OES) State Warning Center at: (800) 852-7550 or (916) 845-8911
 - Lastly follow the required OES procedures as set forth in: http://www.caloes.ca.gov/FireRescueSite/Documents/CalOES-Spill Booklet Feb2014 FINAL BW Acc.pdf
- **ii.** Following notification to OES, the Permittee shall notify Los Angeles Water Board, as soon as practicable (ideally within 24 hours). Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- **iii.** Within five (5) working days of notification to the Los Angeles Water Board, the Permittee must submit an Accidental Discharge of Hazardous Material Report.
- b. Violation of Compliance with Water Quality Standards: The Permittee shall notify the Los Angeles Water Board of any event causing a violation of compliance with water quality standards. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
 - i. Examples of noncompliance events include: lack of storm water treatment following a rain event, discharges causing a visible plume in a water of the state, and water contact with uncured concrete.
 - **ii.** This notification must be followed within three (3) working days by submission of a Violation of Compliance with Water Quality Standards Report.

c. In-Water Work

⁴ "Hazardous material" means any material that, because of its quantity, concentration, or physical or chemical characteristics, poses a significant present or potential hazard to human health and safety or to the environment if released into the workplace or the environment. "Hazardous materials" include, but are not limited to, hazardous substances, hazardous waste, and any material that a handler or the administering agency has a reasonable basis for believing that it would be injurious to the health and safety of persons or harmful to the environment if released into the workplace or the environment. (Health & Saf. Code, § 25501.)

i. If stream diversion will be necessary, the Permittee shall submit to the Los Angeles Water Board staff a Stream Diversion Plan, with a diagram and a narrative description of the method to divert the stream and associated BMPs for acceptance at least 30 days in advance of any stream diversion.

- ii. During stream diversion, water quality monitoring shall be conducted. Requirements for water quality monitoring are in Section XIII, C, 3.
- iii. The Permittee shall notify the Los Angeles Water Board at least forty-eight (48) hours prior to initiating work in water or stream diversions. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- iv. Within three (3) working days following completion of work in water or stream diversions, an In-Water Work/Diversions Water Quality Monitoring Report must be submitted to Los Angeles Water Board staff.

d. Modifications to Project

Project modifications may require an amendment of this Order. The Permittee shall give advance notice to Los Angeles Water Board staff if Project implementation as described in the application materials is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority by submitting a Modifications to Project Report. The Permittee shall inform Los Angeles Water Board staff of any Project modifications that will interfere with the Permittee's compliance with this Order.

- e. Transfer of Property Ownership: This Order is not transferable in its entirety or in part to any person or organization except after notice to the Los Angeles Water Board in accordance with the following terms:
 - i. The Permittee must notify the Los Angeles Water Board of any change in ownership or interest in ownership of the Project area by submitting a Transfer of Property Ownership Report. The Permittee and purchaser must sign and date the notification and provide such notification to the Los Angeles Water Board at least 10 days prior to the transfer of ownership. The purchaser must also submit a written request to the Los Angeles Water Board to be named as the permittee in a revised order.
 - **ii.** Until such time as this Order has been modified to name the purchaser as the permittee, the Permittee shall continue to be responsible for all requirements set forth in this Order.

C. Water Quality Monitoring

 General: If surface water is present, continuous visual surface water monitoring shall be conducted to detect accidental discharge of project related pollutants (e.g. oil and grease, turbidity plume, or uncured concrete).

2. Accidental Discharges/Noncompliance: Upon occurrence of an accidental discharge of hazardous materials or a violation of compliance with a water quality standard. Los Angeles Water Board staff may require water quality monitoring based on the discharge constituents and/or related water quality objectives and beneficial uses.

3. In-Water Work or Diversions:

For projects involving planned work in water or stream diversions, a water quality monitoring plan shall be submitted to Los Angeles Water Board staff for acceptance at least 30 days in advance of any discharge to the affected water body. Water quality monitoring shall be conducted in accordance with the approved plan. During planned work in water or stream diversions any discharge(s) to waters of the state shall conform to the following water quality standards:

- a. Oil and Grease. Waters shall not contain oils, greases, waxes or other materials in concentrations that result in a visible film or coating on the surface of the water or on objects in the water, that cause nuisance, or that otherwise adversely affect beneficial uses.
- b. Dissolved Oxygen. At a minimum, the mean annual dissolved oxygen concentration of all waters shall be greater than 7 mg/L, and no single determination shall be less than 5.0 mg/L, except when natural conditions cause lesser concentrations.
 - The dissolved oxygen content of all surface waters designated as WARM shall not be depressed below 5 mg/L as a result of waste discharges.
- c. pH. The pH of inland surface waters shall not be depressed below 6.5 or raised above 8.5 as a result of waste discharges. Ambient pH levels shall not be changed more than 0.5 units from natural conditions as a result of waste discharge.
- d. Turbidity. Downstream TSS shall be maintained at ambient levels. Where natural turbidity is between 0 and 50 Nephelometric Turbidity Units (NTU), increases shall not exceed 20%. Where natural turbidity is greater than 50 NTU, increases shall not exceed 10%.
- 4. Post-Construction: Visually inspect the Project site during the rainy season to ensure excessive erosion, stream instability, or other water quality pollution is not occurring in or downstream of the Project site. If water quality pollution is occurring, contact the Los Angeles Water Board staff member overseeing the Project within three (3) working days. The Los Angeles Water Board may require the submission of a Violation of Compliance with Water Quality Standards Report. Additional permits may be required to carry out any necessary site remediation.

D. Standard

 This Order is subject to modification or revocation upon administrative or judicial review. including review and amendment pursuant to Water Code section 13330, and California Code of Regulations, title 23, chapter 28, Article 6 commencing with sections 3867-3869, inclusive. Additionally, the Los Angeles Water Board reserves the right to suspend, cancel, or modify and reissue this Order, after providing notice to the Permittee, if the Los Angeles Water Board determines that: the Project fails to comply

with any of the conditions of this Order; or, when necessary to implement any new or revised water quality standards and implementation plans adopted or approved pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.) or federal Clean Water Act section 303 (33 U.S.C. § 1313). For purposes of Clean Water Act section 401(d), the condition constitutes a limitation necessary to assure compliance with water quality standards and appropriate requirements of state law.

- 2. This Order is not intended and shall not be construed to apply to any activity involving a hydroelectric facility requiring a Federal Energy Regulatory Commission (FERC) license or an amendment to a FERC license, unless the pertinent certification application was filed pursuant to subsection 3855(b) of chapter 28, title 23 of the California Code of Regulations, and that application specifically identified that a FERC license or amendment to a FERC license for a hydroelectric facility was being sought.
- 3. This Order is conditioned upon total payment of any fee required under title 23 of the California Code of Regulations and owed by the Permittee.
- 4. In the event of any violation or threatened violation of the conditions of this Order, the violation or threatened violation shall be subject to any remedies, penalties, process, or sanctions as provided for under state and federal law. For purposes of Clean Water Act, section 401(d), the applicability of any state law authorizing remedies, penalties, processes, or sanctions for the violation or threatened violation constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements incorporated into this Order.

E. General Compliance

- 1. Failure to comply with any condition of this Order shall constitute a violation of the Porter-Cologne Water Quality Control Act and the Clean Water Act. The Permittee and/or discharger may then be subject to administrative and/or civil liability pursuant to Water Code section 13385.
- 2. Permitted actions must not cause a violation of any applicable water quality standards, including impairment of designated beneficial uses for receiving waters as adopted in the Basin Plans by any applicable Los Angeles Water Board or any applicable State Water Board (collectively Water Boards) water quality control plan or policy. The source of any such discharge must be eliminated as soon as practicable.
- 3. In response to a suspected violation of any condition of this Order, the Los Angeles Water Board may require the holder of this Order to furnish, under penalty of perjury, any technical or monitoring reports the Water Boards deem appropriate, provide that the burden, including costs, of the reports shall bear a reasonable relationship to the need for the reports and the benefits to be obtained from the reports. The additional monitoring requirements ensure that permitted discharges and activities comport with any applicable effluent limitations, water quality standards, and/or other appropriate requirement of state law.
- **4.** The Permittee must, at all times, fully comply with engineering plans, specifications, and technical reports submitted to support this Order; and all subsequent submittals required as part of this Order. The conditions within this Order and Attachments supersede conflicting provisions within Permittee submittals.

5. This Order and all of its conditions contained herein continue to have full force and effect regardless of the expiration or revocation of any federal license or permit issued for the Project. For purposes of Clean Water Act, section 401(d), this condition constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements of state law.

6. Construction General Permit Requirement: The Permittee shall maintain compliance with conditions described in, and required by, NPDES General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities (Order No. 2009-0009-DWQ; NPDES No. CAS000002).

F. Administrative

- 1. Signatory requirements for all document submittals required by this Order are presented in Attachment A of this Order.
- 2. This Order does not authorize any act which results in the taking of a threatened, endangered or candidate species or any act, which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish & G. Code, §§ 2050-2097) or the federal Endangered Species Act (16 U.S.C. §§ 1531-1544). If a "take" will result from any act authorized under this Order held by the Permittee, the Permittee must obtain authorization for the take prior to any construction or operation of the portion of the Project that may result in a take. The Permittee is responsible for meeting all requirements of the applicable endangered species act for the Project authorized under this Order.
- 3. The Permittee shall grant Los Angeles Water Board staff, or an authorized representative (including an authorized contractor acting as a Water Board representative), upon presentation of credentials and other documents as may be required by law, permission to:
 - **a.** Enter the Project or compensatory mitigation site(s) premises where a regulated facility or activity is located or conducted, or where records are kept.
 - **b.** Have access to and copy any records that are kept and are relevant to the Project or the requirements of this Order.
 - **c.** Inspect any facilities, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order.
 - d. Sample or monitor for the purposes of assuring Order compliance.
- **4.** A copy of this Order shall be provided to any consultants, contractors, and subcontractors working on the Project. Copies of this Order shall remain at the Project site for the duration of this Order. The Permittee shall be responsible for work conducted by its consultants, contractors, and any subcontractors.
- 5. A copy of this Order must be available at the Project site(s) during project activities for review by site personnel and agencies. All personnel performing work on the Project shall be familiar with the content of this Order and its posted location at the Project site.
- **6.** Lake and Streambed Alteration Agreement The Permittee shall submit a signed copy of the Department of Fish and Wildlife's lake and streambed alteration agreement to the

Los Angeles Water Board immediately upon execution and prior to any discharge to waters of the state.

G. Construction The Permittee will comply with the BMPs identified in Section VIII.



- 2. Request for Notice of Completion of Discharges Letter: This request by the Permittee to the Los Angeles Water Board staff pertains to projects that have post construction monitoring requirements, e.g. if site restoration was required to be monitored for 5 years following construction. Los Angeles Water Board staff will review the request and send a Completion of Discharges Letter to the Permittee upon approval. This letter will initiate the post-discharge monitoring period and a change in fees from the annual active discharge fee to the annual post-discharge monitoring fee.
