I. Order

This Clean Water Act (CWA) section 401 Water Quality Certification action and Order (Order) is issued at the request of Los Angeles County Department of Public Works (herein after Permittee) for the Project. This Order is for the purpose described in the application and supplemental information submitted by the Permittee. The application was received on December 22, 2016. The application was deemed complete on January 11, 2017.

II. Public Notice

The Los Angeles Water Board provided public notice of the application pursuant to California Code of Regulations, title 23, section 3858 from December 22, 2016 to January 11, 2017. The Los Angeles Water Board did not receive any comments during the comment period.

III. Project Purpose

The purpose of the project is to perform emergency drainage structure repairs necessary to maintain proper storm flows along Sand Canyon Road which were damaged by the July 2016 Sand Fire.

IV. Project Description

The scope of the project includes removing existing stone headwalls, debris barriers, constructing "L" headwalls, culvert extensions, installing a CMP riser, inlet screens, rail debris, and trash racks at various locations.

V. Project Location

The proposed project is located within the Angeles National Forest in Los Angeles County. The areas where the project repairs will be conducted are specifically located along Sand Canyon Road between Mile Markers 6.13 and 7.98 at: 6.13, 6.23, 6.27, 6.34, 6.51, 6.92, 6.95, 7.33, 7.44, 7.83 and 7.98. A map showing the Project location is found in Attachment B of this Order.

VI. Project Impact and Receiving Waters Information

The Project is located within the jurisdiction of Los Angeles Regional Water Quality Control Board. Receiving waters and groundwater potentially impacted by this Project are protected in

accordance with the applicable water quality control plan (Basin Plan) for the region and other plans and policies which may be accessed online at:

<u>http://www.waterboards.ca.gov/plans_policies/</u>. The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the state, water quality objectives to protect those uses, and the state and federal antidegradation policies.

It is the policy of the State of California that every human being has the right to safe, clean, affordable, and accessible water adequate for human consumption, cooking, and sanitary purposes. This Order promotes that policy by requiring discharges to meet maximum contaminant levels designed to protect human health and ensure that water is safe for domestic use.

VII. Description of Direct Impacts to Waters of the State

The project consists of repairs at eleven (11) locations along Sand Canyon Road. The repairs will include the following at each location.

Site 2. Mile Marker 6.13: At this location, an existing debris barrier will be removed and a trash rack will be installed. Approximately 9.6 cy of concrete and steel will be utilized in the construction within an area of 0.007 acres.

Site 3. Mile Marker 6.23: At this location, an existing stonewall and tree stump will be removed, and an inlet screen will be installed. Repairs also include construction of an "L" headwall and culvert extension. Approximately 1.6 cyof concrete and steel will be utilized in the construction within an area of 0.011 acres.

Site 4. Mile Marker 6.27: At this location, an existing stone headwall will be removed and an inlet screen will be installed. Repairs also include construction of an "L" headwall and culvert extension. Approximately 6.43 c of concrete and steel will be utilized in the construction within an area of 0.011 acres.

Site 5. Mile Marker 6.34: At this location, a twenty-four inch (24") welded CMP riser will be installed, as well as a temporary shoring wall. Approximately 5.51 cy of concrete and steel will be utilized in the construction within an area of 0.055 acres.

Site 6. Mile Marker 6.51: At this location, an existing stone head will be removed, and an inlet screen will be installed. Repairs also include construction of an "L" headwall and culvert extension. Approximately 0.2 cy of concrete and steel will be utilized in the construction within an area of 0.011 acres.

Site 7. Mile Marker 6.92: At this location, an existing inlet screen and debris barrier will be removed and a rail debris barrier will be intalled. Approximately 6.43 cy of concrete and steel will be utilized in the construction within an area of 0.006 acres.

Site 8. Mile Marker 6.95: At this location, a trash rack will be installed. Approximately 3.6 cy of concrete and steel will be utilized in the construction within an area of 0.04 acres.

Site 9. Mile Marker 7.33: At this location, an existing stone headwall will be removed and an inlet screen will be installed. Approximately 1.1 cy of concrete and steel will be utilized in the construction within an area of 0.014 acres.

Site 10. Mile Marker 7.44: At this location, an inlet screen will be installed. Approximately 1.1 cy of concrete and steel will be utilized in the construction within an area of 0.034 acres.

Site 11. Mile Marker 7.83: At this location, an inlet screen will be installed. Repairs also include the construction of an "L" headwall and culvert extension. Approximately 6.43 cy of concrete and steel will be utilized within an area of 0.03 acres.

Site 12. Mile Marker 7.98: At this location, an inlet screen will be installed. Approximately 1.1 cy of concrete and steel will be utilized within an area of 0.02 acres.

Total Project fill/excavation quantities for all impacts are summarized in Table 2. Permanent impacts are categorized as those resulting in a physical loss in area and also those degrading ecological condition only.

VIII. Description of Indirect Impacts to Waters of the State

The Los Angeles Water Board recognizes the potential for indirect impacts to waters of the state associated with the Project. This project does not have any adverse effects due to indirect impacts.

IX. Avoidance and Minimization

The proposed project has been minimized to the maximum extent feasible and only areas in which emergency repairs are required will be impacted.

X. Compensatory Mitigation

The Permittee is required to provide a total of 0.516 acres of compensatory mitigation at a 2:1 ratio for 0.018 acres of permanent direct impacts and 0.24 temporary direct impacts, described in section VII for permanent impacts. Mitigation will include restoration and enhancement in the project area.

XI. California Environmental Quality Act (CEQA)

The Los Angeles Water Board has determined that the Project is exempt from review under CEQA pursuant to California Water Code of Regulations, title 14, section 15061. Specifically, the issuance of this Order and the activities described herein meet the exemption criteria under California Code of Regulations title 14, Section 15302, Replacement or reconstruction. Additionally, the Los Angeles Water Board concludes that no exceptions to the CEQA exemption apply to the activities approved by this Order.

XII. Petitions for Reconsideration

Any person aggrieved by this action may petition the State Water Board to reconsider this Order in accordance with California Code of Regulations, title 23, section 3867. A petition for reconsideration must be submitted in writing and received within 30 calendar days of the issuance of this Order.

XIII. Fees Received

An application fee of \$2449.00 was received on January 11, 2017. The fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.

XIV. Conditions

The Los Angeles Water Board has independently reviewed the record of the Project to analyze impacts to the environment and designated beneficial uses within the watershed of the Project. In accordance with this Order, the Permittee may proceed with the Project under the following terms and conditions:

A. Authorization

Impacts to waters of the state shall not exceed quantities shown in Table 2.

B. Reporting and Notification Requirements

The following section details the reporting and notification types and timing of submittals. Requirements for the content of these reporting and notification types are detailed in Attachment C, including specifications for photo and map documentation during the Project. Written reports and notifications must be submitted using the Reporting and Notification Cover Sheet located in Attachment C, which must be signed by the Permittee or an authorized representative.

1. Project Reporting

a. Annual Reporting: The Permittee shall submit an Annual Report each year on January 1st of the year following project completion. Annual reporting shall continue until a Notice of Project Complete Letter is issued to the Permittee.

2. Project Status Notifications

a. Request for Notice of Completion of Discharges Letter: The Permittee shall submit a Request for Notice of Completion of Discharges Letter following completion of active Project construction activities, including any required restoration and permittee-responsible mitigation. This request shall be submitted to the Los Angeles Water Board staff within thirty (30) days following completion of all Project construction activities. Upon acceptance of the request, Los Angeles Water Board staff shall issue a Notice of Completion of Discharges Letter to the Permittee which will end the active discharge period and associated annual fees.

- **b.** Request for Notice of Project Complete Letter: The Permittee shall submit a Request for Notice of Project Complete Letter when construction and/or any post-construction monitoring is complete,³ and no further Project activities will occur. This request shall be submitted to Los Angeles Water Board staff within thirty (30) days following completion of all Project activities. Upon approval of the request, the Los Angeles Water Board staff shall issue a Notice of Project Complete Letter to the Permittee which will end the post discharge monitoring period and associated annual fees.
- **3. Conditional Notifications and Reports:** The following notifications and reports are required as appropriate.

a. Accidental Discharges of Hazardous Materials⁴

Following an accidental discharge of a reportable quantity of a hazardous material, sewage, or an unknown material, the following applies (Wat. Code, § 13271):

- As soon as (A) Permittee has knowledge of the discharge or noncompliance,
 (B) notification is possible, and (C) notification can be provided without substantially impeding cleanup or other emergency measures then:
 - first call 911 (to notify local response agency)
 - then call Office of Emergency Services (OES) State Warning Center at: (800) 852-7550 or (916) 845-8911
 - Lastly follow the required OES procedures as set forth in: <u>http://www.caloes.ca.gov/FireRescueSite/Documents/CalOES-Spill_Booklet_Feb2014_FINAL_BW_Acc.pdf</u>
- **ii.** Following notification to OES, the Permittee shall notify Los Angeles Water Board, as soon as practicable (ideally within 24 hours). Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- **iii.** Within five (5) working days of notification to the Los Angeles Water Board, the Permittee must submit an Accidental Discharge of Hazardous Material Report.
- **b.** Violation of Compliance with Water Quality Standards: The Permittee shall notify the Los Angeles Water Board of any event causing a violation of compliance

⁴ "Hazardous material" means any material that, because of its quantity, concentration, or physical or chemical characteristics, poses a significant present or potential hazard to human health and safety or to the environment if released into the workplace or the environment. "Hazardous materials" include, but are not limited to, hazardous substances, hazardous waste, and any material that a handler or the administering agency has a reasonable basis for believing that it would be injurious to the health and safety of persons or harmful to the environment if released into the workplace or the environment. (Health & Saf. Code, § 25501.)

with water quality standards. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.

- i. Examples of noncompliance events include: lack of storm water treatment following a rain event, discharges causing a visible plume in a water of the state, and water contact with uncured concrete.
- **ii.** This notification must be followed within three (3) working days by submission of a Violation of Compliance with Water Quality Standards Report.

c. In-Water Work

- i. The Permittee shall notify the Los Angeles Water Board at least forty-eight (48) hours prior to initiating work in water or stream diversions. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- **ii.** Within fifteen (15) working days following completion of work in water or stream diversions, an In-Water Work/Diversions Water Quality Monitoring Report must be submitted to Los Angeles Water Board staff.

d. Modifications to Project

Project modifications may require an amendment of this Order. The Permittee shall give advance notice to Los Angeles Water Board staff if Project implementation as described in the application materials is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority by submitting a Modifications to Project Report. The Permittee shall inform Los Angeles Water Board staff of any Project modifications that will interfere with the Permittee's compliance with this Order.

- e. Transfer of Property Ownership: This Order is not transferable in its entirety or in part to any person or organization except after notice to the Los Angeles Water Board in accordance with the following terms:
 - i. The Permittee must notify the Los Angeles Water Board of any change in ownership or interest in ownership of the Project area by submitting a Transfer of Property Ownership Report. The Permittee and purchaser must sign and date the notification and provide such notification to the Los Angeles Water Board at least 10 days prior to the transfer of ownership.
 - **ii.** Until such time as this Order has been modified to name the purchaser as the permittee, the Permittee shall continue to be responsible for all requirements set forth in this Order.

C. Water Quality Monitoring

1. General: If surface water is present, continuous visual surface water monitoring shall be conducted to detect accidental discharge of construction related pollutants (e.g. oil and grease, turbidity plume, uncured concrete).

2. Accidental Discharges/Noncompliance: Upon occurrence of an accidental discharge of hazardous materials or a violation of compliance with a water quality standard, Los Angeles Water Board staff may require water quality monitoring based on the discharge constituents and/or related water quality objectives and beneficial uses.

3. In-Water Work or Diversions:

For projects involving planned work in water or stream diversions, a water quality monitoring plan shall be submitted to Los Angeles Water Board staff for acceptance at least 30 days in advance of any discharge to the affected water body. Water quality monitoring shall be conducted in accordance with the approved plan.

During planned work in water or stream diversions any discharge(s) to waters of the state shall conform to the following water quality standards:

- **a.** Oil and Grease. Waters shall not contain oils, greases, waxes or other materials in concentrations that result in a visible film or coating on the surface of the water or on objects in the water, that cause nuisance, or that otherwise adversely affect beneficial uses.
- b. Turbidity. Downstream TSS shall be maintained at ambient levels. Where natural turbidity is between 0 and 50 Nephelometric Turbidity Units (NTU), increases shall not exceed 20%. Where natural turbidity is greater than 50 NTU, increases shall not exceed 10%.
- **c.** pH. The pH of inland surface waters shall not be depressed below 6.5 or raised above 8.5 as a result of waste discharges. Ambient pH levels shall not be changed more than 0.5 units from natural conditions as a result of waste discharge
- 4. Post-Construction: Visually inspect the Project site during the rainy season for one year to ensure excessive erosion, stream instability, or other water quality pollution is not occurring in or downstream of the Project site. If water quality pollution is occurring, contact the Los Angeles Water Board staff member overseeing the Project within three (3) working days. Additional permits may be required to carry out any necessary site remediation.

D. Standard

1. This Order is subject to modification or revocation upon administrative or judicial review, including review and amendment pursuant to Water Code section 13330, and California Code of Regulations, title 23, chapter 28, Article 6 commencing with sections 3867-3869, inclusive. Additionally, the Los Angeles Water Board reserves the right to suspend, cancel, or modify and reissue this Order, after providing notice to the Permittee, if the Los Angeles Water Board determines that: the Project fails to comply with any of the conditions of this Order; or, when necessary to implement any new or revised water quality standards and implementation plans adopted or approved pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.) or federal Clean Water Act section 303 (33 U.S.C. § 1313). For purposes of Clean Water Act section 401(d), the condition constitutes a limitation necessary to assure compliance with water quality standards and appropriate requirements of state law.

- 2. This Order is not intended and shall not be construed to apply to any activity involving a hydroelectric facility requiring a Federal Energy Regulatory Commission (FERC) license or an amendment to a FERC license, unless the pertinent certification application was filed pursuant to subsection 3855(b) of chapter 28, title 23 of the California Code of Regulations, and that application specifically identified that a FERC license or amendment to a FERC license for a hydroelectric facility was being sought.
- 3. This Order is conditioned upon total payment of any fee required under title 23 of the California Code of Regulations and owed by the Permittee.
- 4. In the event of any violation or threatened violation of the conditions of this Order, the violation or threatened violation shall be subject to any remedies, penalties, process, or sanctions as provided for under state and federal law. For purposes of Clean Water Act, section 401(d), the applicability of any state law authorizing remedies, penalties, processes, or sanctions for the violation or threatened violation constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements incorporated into this Order.

E. General Compliance

- 1. Failure to comply with any condition of this Order shall constitute a violation of the Porter-Cologne Water Quality Control Act and the Clean Water Act. The Permittee and/or discharger may then be subject to administrative and/or civil liability pursuant to Water Code section 13385.
- 2. Permitted actions must not cause a violation of any applicable water quality standards, including impairment of designated beneficial uses for receiving waters as adopted in the Basin Plans by any applicable Los Angeles Water Board or any applicable State Water Board (collectively Water Boards) water quality control plan or policy. The source of any such discharge must be eliminated as soon as practicable.
- 3. In response to a suspected violation of any condition of this Order, the Los Angeles Water Board may require the holder of this Order to furnish, under penalty of perjury, any technical or monitoring reports the Water Boards deem appropriate, provide that the burden, including costs, of the reports shall bear a reasonable relationship to the need for the reports and the benefits to be obtained from the reports. The additional monitoring requirements ensure that permitted discharges and activities comport with any applicable effluent limitations, water quality standards, and/or other appropriate requirement of state law.
- **4.** The Permittee must, at all times, fully comply with engineering plans, specifications, and technical reports submitted to support this Order; and all subsequent submittals required as part of this Order. The conditions within this Order and Attachments supersede conflicting provisions within Permittee submittals.
- **5.** This Order and all of its conditions contained herein continue to have full force and effect regardless of the expiration or revocation of any federal license or permit issued for the Project. For purposes of Clean Water Act, section 401(d), this condition constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements of state law.

F. Administrative

- **1.** Signatory requirements for all document submittals required by this Order are presented in Attachment A of this Order.
- 2. This Order does not authorize any act which results in the taking of a threatened, endangered or candidate species or any act, which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish & G. Code, §§ 2050-2097) or the federal Endangered Species Act (16 U.S.C. §§ 1531-1544). If a "take" will result from any act authorized under this Order held by the Permittee, the Permittee must obtain authorization for the take prior to any construction or operation of the portion of the Project that may result in a take. The Permittee is responsible for meeting all requirements of the applicable endangered species act for the Project authorized under this Order.
- **3.** The Permittee shall grant Los Angeles Water Board staff, or an authorized representative (including an authorized contractor acting as a Water Board representative), upon presentation of credentials and other documents as may be required by law, permission to:
 - **a.** Enter upon the Project or compensatory mitigation site(s) premises where a regulated facility or activity is located or conducted, or where records are kept.
 - **b.** Have access to and copy any records that are kept and are relevant to the Project or the requirements of this Order.
 - **c.** Inspect any facilities, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order.
 - **d.** Sample or monitor for the purposes of assuring Order compliance.
- **4.** A copy of this Order shall be provided to any consultants, contractors, and subcontractors working on the Project. Copies of this Order shall remain at the Project site for the duration of this Order. The Permittee shall be responsible for work conducted by its consultants, contractors, and any subcontractors.
- 5. A copy of this Order must be available at the Project site(s) during construction for review by site personnel and agencies. All personnel performing work on the Project shall be familiar with the content of this Order and its posted location at the Project site.
- 6. Lake and Streambed Alteration Agreement The Permittee shall submit a signed copy of the Department of Fish and Wildlife's lake and streambed alteration agreement to the Los Angeles Water Board immediately upon execution and prior to any discharge to waters of the state.

G. Construction

Good Site Management "Housekeeping"

- 1. The Permittee is not authorized to discharge water that has contacted uncured concrete or cement, or related washout to surface waters, ground waters, or land.
- 2. Fueling, lubrication, maintenance, storage and staging of vehicles and equipment shall not result in a discharge or a threatened discharge to any waters of the state. The Permittee shall not use leaking vehicles or equipment within waters of the state or where leaking materials may discharge to waters of the state

- **3.** BMPs for erosion, sediment and turbidity control shall be implemented and in place at commencement of, during and after any ground-clearing activities or any other project activities that could result in erosion or sediment discharges to surface water.
- 4. The project shall comply with the local regulations associated with the Los Angeles Water Board's Municipal Stormwater Permit issued to Los Angeles County and copermittees under NPDES No. CAS004001 and Waste Discharge Requirements Order No. R4-2012-0175.

Post-Construction Storm Water Management

- 5. Culverts, or other structures shall be installed so that water flow is not impaired. Bottoms of temporary culverts shall be placed at water body grade and bottoms of permanent culverts shall be placed at or below water body grade.
- 6. Storm drain lines/culverts, outfall structure, and other water body crossing structures shall be properly aligned within the water body and otherwise engineered, installed, and maintained, to assure resistance to washout, and to prevent erosion and/or fill of the water body. Water velocity shall be dissipated at outfalls to reduce erosion.

H. Mitigation for Temporary Impacts

- 1. The Permittee shall restore all areas of temporary impacts to waters of the state and all Project site upland areas of temporary disturbance which could result in a discharge of waters of the state. The restoration plan shall be submitted for written acceptance by Los Angeles Water Board staff within ninety days (90) of issuance of this Order. The restoration plan shall provide the following: a schedule; plans for grading of disturbed areas to pre-project contours; planting palette with plant species native to the Project area; seed collection location; invasive species management; performance standards; and maintenance requirements (e.g. watering, weeding, and replanting).
- 2. The Los Angeles Water Board may extend the monitoring period beyond requirements of the restoration plan upon a determination by Los Angeles Water Board Executive Officer that the performance standards have not been met or are not likely to be met within the monitoring period.

I. Compensatory Mitigation for Permanent Impacts⁵

1. Compensatory Mitigation Plan

a. The Permittee has not submitted an approved draft compensatory mitigation plan as part of the application. The Permittee shall provide a final compensatory mitigation plan for written acceptance by Los Angeles Water Board staff within 90 days of issuance of this Order. Upon acceptance by Los Angeles Water Board staff, the Permittee shall implement the approved plan.

⁵ Compensatory Mitigation is for permanent physical loss and permanent ecological degradation of a water of the state.

- **b.** The final compensatory mitigation plan shall include all plan elements as outlined in 40 CFR § 230.94(c).
- **c.** Permittees fulfilling their compensatory mitigation obligations by securing credits from an approved mitigation bank or in-lieu fee program, need only include the items described in 40 CFR § 230.94(c)(5)-(6), and the name of the specific mitigation bank or in-lieu fee program to be used.

XV. Water Quality Certification

I hereby issue the Order for the Sand Canyon Road Drainage Structure Repairs Project, 4WQC40116165 certifying that as long as all of the conditions listed in this Order are met, any discharge from the referenced Project will comply with the applicable provisions of Clean Water Act sections 301 (Effluent Limitations), 302 (Water Quality Related Effluent Limitations), 303 (Water Quality Standards and Implementation Plans), 306 (National Standards of Performance), and 307 (Toxic and Pretreatment Effluent Standards).

Except insofar as may be modified by any preceding conditions, all Order actions are contingent on: (a) the discharge being limited and all proposed mitigation being completed in strict compliance with the conditions of this Order and the attachments to this Order; and, (b) compliance with all applicable requirements of Statewide Water Quality Control Plans and Policies and the Regional Water Boards' Water Quality Control Plans and Policies.
