#### I. Order

This Clean Water Act (CWA) section 401 Water Quality Certification action and Order (Order) is issued at the request of Gate King Properties, LLC (hereinafter Permittee) for the Project. This Order is for the purpose described in application and supplemental information submitted by the Permittee. The application was received on December 21, 2017. The application was deemed complete on April 18, 2018.

#### II. Public Notice

The Los Angeles Water Board provided public notice of the application pursuant to California Code of Regulations, title 23, section 3858 from December 22, 2017 to the effective date of Order. The Los Angeles Water Board did not receive any comments during the comment period.

#### III. Project Purpose

The purpose of the Project is to develop an industrial park on a portion of the Gate King property (historically known as Needham Ranch), which encompasses 584 acres in the City of Santa Clarita.

## IV. Project Description

The Los Angeles Water Board issued a CWA section 401 Water Quality Certification for the Project on December 17, 2012 (File No. 11-123) and amended the CWA section 401 Water Quality Certification twice, on May 7, 2013 and March 6, 2017. The CWA section 401 Water Quality Certification (File No. 11-123) is now expired. This Order provides for completion of the Project. This Project Description describes the entire Project.

The Gate King property was purchased by the Gates Family in 1957. Since then, a considerable portion of the property has been dedicated to the City of Santa Clarita. In addition, an easement for the Metropolitan Water District exists for the previous development of a tunnel for the California Water Project. An additional parcel was sold for the Eternal Valley Memorial Park (cemetery) and a portion was sold to the State of California for State Route 14 (SR-14).

The Project is the development of approximately 184 acres, within the 584-acre site. Within the property, there are 38 ephemeral drainages. Of these drainages, 19 will not be impacted. The total linear feet of jurisdictional drainages on the property is 47,225 feet. Of the total 7.90 acres of jurisdictional waters on-site, the project avoids 5.42 acres. Approximately 3.47 acres of the avoided jurisdictional areas are within the City-dedicated wilderness open space, and an additional 1.95 acres occur within the project limits.

Grading of the project site will occur in phases to ensure that prompt re-vegetation or construction will limit impacts due to erosion. The industrial commercial development is planned to occur in three (3) or four (4) phases over an approximate 5-year time period.

The goal of the overall development is to provide the following benefits:

- · Provide recreational and open space facilities for the public.
- Protection of sensitive resources by providing open space and wildlife corridors.
- Preserving approximately 330 acres of on-site and adjacent open space in perpetuity.
- Retaining major open areas which shall act as regional ecological preserves and migration corridors.
- Providing an employment center in proximity to alternative transportation modes, such as Metrolink rail service.

As of the date of this Order, the overall impacts are 56% complete (approximately 148 acres Phase 1 impacted; the remaining approximately 114 acres, Phase 2 and 3 impacts, have not yet been permanently impacted). To date, the impacts to the Waters of the US are 38% complete (0.95 acres Phase 1 impacted; 0.98 acres Phase 2 not permanently impacted yet (only vegetation removal); 0.55 acres Phase 3 not impacted yet).

#### VI. Project Impact and Receiving Waters Information

The Project is located within the jurisdiction of Los Angeles Regional Water Quality Control Board. Receiving waters and groundwater potentially impacted by this Project are protected in accordance with the applicable water quality control plan (Basin Plan) for the region and other plans and policies which may be accessed online at:

http://www.waterboards.ca.gov/plans policies/. The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the state, water quality objectives to protect those uses, and the state and federal antidegradation policies.

It is the policy of the State of California that every human being has the right to safe, clean, affordable, and accessible water adequate for human consumption, cooking, and sanitary purposes. This Order promotes that policy by requiring discharges to meet maximum contaminant levels designed to protect human health and ensure that water is safe for domestic use.

#### VIII. Description of Indirect Impacts to Waters of the State

The Los Angeles Water Board recognizes the potential for indirect impacts to waters of the state associated with the Project. If performed as described, no measurable or significant indirect impacts are expected.

#### IX. Avoidance and Minimization

The project avoids a total of 5.42 acres of Waters of the United States (3.47 of which is found in the open space).

#### X. Compensatory Mitigation

The Permittee has agreed to provide compensatory mitigation for direct, described in section XIV, I for permanent impacts.

#### XI. California Environmental Quality Act (CEQA)

On June 25, 2003, the City of Santa Clarita, as lead agency, certified an environmenal impact report (EIR) (State Clearinghouse (SCH) No. 2001021121) for the Project. The Los Angeles Water Board is a responsible agency under CEQA (Pub. Resources Code, § 21069) and in making its determinations and findings, must presume that the lead agency's certified environmental document comports with the requirements of CEQA and is valid. (Pub. Resources Code, § 21167.3.) The Los Angeles Water Board has reviewed and considered the environmental document and finds that the environmental document prepared by the lead agency addresses the Project's water resource impacts. (Cal. Code Regs., tit. 14, § 15096, subd. (f).) The environmental document includes the mitigation monitoring and reporting program (MMRP) for all mitigation measures that have been adopted for the Project to reduce potential significant impacts. (Pub. Resources Code, § 21081.6, subd. (a)(1); Cal. Code Regs., tit. 14, § 15091, subd. (d).)

#### XII. Petitions for Reconsideration

Any person aggrieved by this action may petition the State Water Board to reconsider this Order in accordance with California Code of Regulations, title 23, section 3867. A petition for reconsideration must be submitted in writing and received within 30 calendar days of the issuance of this Order.

#### XIII. Fees Received

An application fee of \$720 was received on December 22, 2017. This certificate is conditioned upon total payment of \$32,905. The fee amount was determined as required by

California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.

#### XIV. Conditions

The Los Angeles Water Board has independently reviewed the record of the Project to analyze impacts to water quality and designated beneficial uses within the watershed of the Project. In accordance with this Order, the Permittee may proceed with the Project under the following terms and conditions:

#### A. Authorization

Impacts to waters of the state shall not exceed quantities shown in Table 1.

#### B. Reporting and Notification Requirements

Requirements for the content of these reporting and notification types are detailed in Attachment C, including specifications for photo and map documentation during the Project. Written reports and notifications must be submitted using the Reporting and Notification Cover Sheet located in Attachment C, which must be signed by the Permittee or an authorized representative.

#### 1. Project Reporting

a. Annual Reporting: The Permittee shall submit an Annual Report each year on the anniversary of Project effective date. Annual reporting shall continue until a Notice of Project Complete Letter is issued to the Permittee.

#### 2. Project Status Notifications

- a. Commencement of Construction: The Permittee shall submit a Commencement of Construction Report at least seven (7) days prior to start of initial ground disturbance activities.
- b. Request for Notice of Completion of Discharges Letter: The Permittee shall submit a Request for Notice of Completion of Discharges Letter following completion of active Project construction activities, including any required restoration and permittee-responsible mitigation. This request shall be submitted to the Los Angeles Water Board staff within thirty (30) days following completion of all Project construction activities. Upon acceptance of the request, Los Angeles Water Board staff shall issue a Notice of Completion of Discharges Letter to the Permittee which will end the active discharge period and associated annual fees.
- c. Request for Notice of Project Complete Letter: The Permittee shall submit a Request for Notice of Project Complete Letter when construction and/or any post-construction monitoring is complete,<sup>3</sup> and no further Project activities will occur. This request shall be submitted to Los Angeles Water Board staff within thirty (30) days following completion of all Project activities. Upon approval of the request, the Los Angeles Water Board staff

shall issue a Notice of Project Complete Letter to the Permittee which will end the post discharge monitoring period and associated annual fees.

3. Conditional Notifications and Reports: The following notifications and reports are required as appropriate.

#### a. Accidental Discharges of Hazardous Materials<sup>4</sup>

Following an accidental discharge of a reportable quantity of a hazardous material, sewage, or an unknown material, the following applies (Wat. Code, § 13271):

- As soon as (A) Permittee has knowledge of the discharge or noncompliance, (B) notification is possible, and (C) notification can be provided without substantially impeding cleanup or other emergency measures then:
  - first call 911 (to notify local response agency)
  - then call Office of Emergency Services (OES) State Warning Center at: (800) 852-7550 or (916) 845-8911
  - Lastly follow the required OES procedures as set forth in: http://www.caloes.ca.gov/FireRescueSite/Documents/CalOES-Spill Booklet Feb2014 FINAL BW Acc.pdf
- Following notification to OES, the Permittee shall notify Los Angeles Water ii. Board, as soon as practicable (ideally within 24 hours). Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- iii. Within five (5) working days of notification to the Los Angeles Water Board, the Permittee must submit an Accidental Discharge of Hazardous Material Report.
- b. Violation of Compliance with Water Quality Standards: The Permittee shall notify the Los Angeles Water Board of any event causing a violation of compliance with water quality standards. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
  - Examples of noncompliance events include: lack of storm water treatment following a rain event, discharges causing a visible plume in a water of the state, and water contact with uncured concrete.
  - This notification must be followed within three (3) working days by submission ii. of a Violation of Compliance with Water Quality Standards Report.

#### c. In-Water Work

"Hazardous materials" include, but are not limited to, hazardous substances, hazardous waste, and any material that a handler or the administering agency has a reasonable basis for believing that it would be injurious to the health and safety of persons or harmful to the environment if released into the workplace or the environment. (Health & Saf. Code, § 25501.)

i. The Permittee shall notify the Los Angeles Water Board at least forty-eight (48) hours prior to initiating work in water or stream diversions. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.

ii. The Permittee shall submit to Los Angeles Water Board staff In-Water Work/Diversions Water Quality Monitoring Reports per Section XIV, C, 3, below.

#### d. Modifications to Project

Project modifications may require an amendment of this Order. The Permittee shall give advance notice to Los Angeles Water Board staff if Project implementation as described in the application materials is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority by submitting a Modifications to Project Report. The Permittee shall inform Los Angeles Water Board staff of any Project modifications that will interfere with the Permittee's compliance with this Order.

- e. Transfer of Property Ownership: This Order is not transferable in its entirety or in part to any person or organization except after notice to the Los Angeles Water Board in accordance with the following terms:
  - i. The Permittee must notify the Los Angeles Water Board of any change in ownership or interest in ownership of the Project area by submitting a Transfer of Property Ownership Report. The Permittee and purchaser must sign and date the notification and provide such notification to the Los Angeles Water Board at least 10 days prior to the transfer of ownership. The purchaser must also submit a written request to the Los Angeles Water Board to be named as the permittee in a revised order.
  - **ii.** Until such time as this Order has been modified to name the purchaser as the permittee, the Permittee shall continue to be responsible for all requirements set forth in this Order.
- f. Transfer of Long-Term BMP Maintenance: If maintenance responsibility for post-construction BMPs is legally transferred, the Permittee must submit to the Los Angeles Water Board a copy of such documentation and must provide the transferee with a copy of a long-term BMP maintenance plan that complies with manufacturer or designer specifications. The Permittee must provide such notification to the Los Angeles Water Board with a Transfer of Long-Term BMP Maintenance Report at least 10 days prior to the transfer of BMP maintenance responsibility.

## C. Water Quality Monitoring

- General: If surface water is present, continuous visual surface water monitoring shall be conducted to detect accidental discharge of construction related pollutants (e.g. oil and grease, turbidity plume, or uncured concrete).
- 2. Accidental Discharges/Noncompliance: Upon occurrence of an accidental discharge of hazardous materials or a violation of compliance with a water quality standard, Los

Angeles Water Board staff may require water quality monitoring based on the discharge constituents and/or related water quality objectives and beneficial uses.

#### 3. In-Water Work or Diversions:

During planned work in water or stream diversions any discharge(s) to waters of the state shall conform to the following water quality standards:

- a. Oil and Grease. Waters shall not contain oils, greases, waxes or other materials in concentrations that result in a visible film or coating on the surface of the water or on objects in the water, that cause nuisance, or that otherwise adversely affect beneficial uses.
- **b.** Dissolved Oxygen. At a minimum, the mean annual dissolved oxygen concentration of all waters shall be greater than 7 mg/L, and no single determination shall be less than 5.0 mg/L, except when natural conditions cause lesser concentrations.
- c. pH. The pH of inland surface waters shall not be depressed below 6.5 or raised above 8.5 as a result of waste discharges. Ambient pH levels shall not be changed more than 0.5 units from natural conditions as a result of waste discharge.
- **d.** Turbidity. Downstream TSS shall be maintained at ambient levels. Where natural turbidity is between 0 and 50 Nephelometric Turbidity Units (NTU), increases shall not exceed 20%. Where natural turbidity is greater than 50 NTU, increases shall not exceed 10%.

Sampling shall be conducted in accordance with Table 2 sampling parameters.5

<sup>&</sup>lt;sup>5</sup> Pollutants shall be analyzed using the analytical methods described in 40 Code of Federal Regulations Part 136; where no methods are specified for a given pollutant, the method shall be approved by Los Angeles Water Board staff. Grab samples shall be taken between the surface and mid-depth and not be collected at the same time each day to get a complete representation of variations in the receiving water. A hand-held field meter may be used, provided the meter utilizes a U.S. EPA-approved algorithm/method and is calibrated and maintained in accordance with the manufacturer's instructions. A calibration and maintenance log for each meter used for monitoring shall be maintained onsite.

Baseline sampling shall be conducted at least one location within the project boundary for each phase. All other sampling shall take place at a minimum of two locations. In streams or flowing water the sample locations shall be upstream and downstream. Results of the analyses shall be submitted to this Regional Board by the 15th day of each subsequent sampling month. A map or drawing indicating the locations of sampling points shall be included with each submittal.

4. Post-Construction: Visually inspect the Project site during the rainy season for 5 years to ensure excessive erosion, stream instability, or other water quality pollution is not occurring in or downstream of the Project site. If water quality pollution is occurring, contact the Los Angeles Water Board staff member overseeing the Project within three (3) working days. The Los Angeles Water Board may require the submission of a Violation of Compliance with Water Quality Standards Report. Additional permits may be required to carry out any necessary site remediation.

#### D. Standard

- 1. This Order is subject to modification or revocation upon administrative or judicial review, including review and amendment pursuant to Water Code section 13330, and California Code of Regulations, title 23, chapter 28, Article 6 commencing with sections 3867-3869, inclusive. Additionally, the Los Angeles Water Board reserves the right to suspend, cancel, or modify and reissue this Order, after providing notice to the Permittee, if the Los Angeles Water Board determines that: the Project fails to comply with any of the conditions of this Order; or, when necessary to implement any new or revised water quality standards and implementation plans adopted or approved pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.) or federal Clean Water Act section 303 (33 U.S.C. § 1313). For purposes of Clean Water Act section 401(d), the condition constitutes a limitation necessary to assure compliance with water quality standards and appropriate requirements of state law.
- 2. This Order is not intended and shall not be construed to apply to any activity involving a hydroelectric facility requiring a Federal Energy Regulatory Commission (FERC) license or an amendment to a FERC license, unless the pertinent certification application was filed pursuant to subsection 3855(b) of chapter 28, title 23 of the California Code of Regulations, and that application specifically identified that a FERC license or amendment to a FERC license for a hydroelectric facility was being sought.
- 3. This Order is conditioned upon total payment of any fee required under title 23 of the California Code of Regulations and owed by the Permittee.
- 4. In the event of any violation or threatened violation of the conditions of this Order, the violation or threatened violation shall be subject to any remedies, penalties, process, or sanctions as provided for under state and federal law. For purposes of Clean Water Act, section 401(d), the applicability of any state law authorizing remedies, penalties, processes, or sanctions for the violation or threatened violation constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements incorporated into this Order.

#### E. General Compliance

- 1. Failure to comply with any condition of this Order shall constitute a violation of the Porter-Cologne Water Quality Control Act and the Clean Water Act. The Permittee and/or discharger may then be subject to administrative and/or civil liability pursuant to Water Code section 13385.
- 2. Permitted actions must not cause a violation of any applicable water quality standards, including impairment of designated beneficial uses for receiving waters as adopted in the Basin Plans by any applicable Los Angeles Water Board or any applicable State Water Board (collectively Water Boards) water quality control plan or policy. The source of any such discharge must be eliminated as soon as practicable.
- 3. In response to a suspected violation of any condition of this Order, the Los Angeles Water Board may require the holder of this Order to furnish, under penalty of perjury, any technical or monitoring reports the Water Boards deem appropriate, provide that the burden, including costs, of the reports shall bear a reasonable relationship to the need for the reports and the benefits to be obtained from the reports. The additional monitoring requirements ensure that permitted discharges and activities comport with any applicable effluent limitations, water quality standards, and/or other appropriate requirement of state law.
- **4.** The Permittee must, at all times, fully comply with engineering plans, specifications, and technical reports submitted to support this Order; and all subsequent submittals required as part of this Order. The conditions within this Order and Attachments supersede conflicting provisions within Permittee submittals.
- 5. This Order and all of its conditions contained herein continue to have full force and effect regardless of the expiration or revocation of any federal license or permit issued for the Project. For purposes of Clean Water Act, section 401(d), this condition constitutes a limitation necessary to assure compliance with the water quality standards and other pertinent requirements of state law.
- 6. Construction General Permit Requirement: The Permittee shall maintain compliance with conditions described in, and required by, NPDES General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities (Order No. 2009-0009-DWQ as amended; NPDES No. CAS000002).

#### F. Administrative

- 1. Signatory requirements for all document submittals required by this Order are presented in Attachment B of this Order.
- 2. This Order does not authorize any act which results in the taking of a threatened, endangered or candidate species or any act, which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish & G. Code, §§ 2050-2097) or the federal Endangered Species Act (16 U.S.C. §§ 1531-1544). If a "take" will result from any act authorized under this Order held by the Permittee, the Permittee must obtain authorization for the take prior to any construction or operation of the portion of the Project that may result in a take. The Permittee is responsible for meeting all requirements of the applicable endangered species act for the Project authorized under this Order.

- 3. The Permittee shall grant Los Angeles Water Board staff, or an authorized representative (including an authorized contractor acting as a Water Board representative), upon presentation of credentials and other documents as may be required by law, permission to:
  - **a.** Enter upon the Project or compensatory mitigation site(s) premises where a regulated facility or activity is located or conducted, or where records are kept.
  - **b.** Have access to and copy any records that are kept and are relevant to the Project or the requirements of this Order.
  - **c.** Inspect any facilities, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order.
  - d. Sample or monitor for the purposes of assuring Order compliance.
- **4.** A copy of this Order shall be provided to any consultants, contractors, and subcontractors working on the Project. Copies of this Order shall remain at the Project site for the duration of this Order. The Permittee shall be responsible for work conducted by its consultants, contractors, and any subcontractors.
- **5.** A copy of this Order must be available at the Project site(s) during construction for review by site personnel and agencies. All personnel performing work on the Project shall be familiar with the content of this Order and its posted location at the Project site.
- **6.** This Order shall expire **five (5) years** from date of this Order. The Applicant shall submit a complete application at least 90 days prior to termination of this Order if renewal is requested.

#### G. Best Management Practices

- 1. Good Site Management "Housekeeping"
  - All storage areas including soil piles and fuel and chemical depots shall be covered with plastic sheets and temporary roofs.
  - All construction-related equipment and related processes that contain or generate pollutants such as fuel, lubricants, solvents, cement dust, and slurry shall be kept in isolated areas in bermed, plastic-lined depressions to contain all materials.
  - All construction vehicles and equipment shall be parked, fueled and cleaned in one designated, contained, area.
  - Downstream drainages shall be protected from pollutants by capturing materials carried in runoff and preventing transport from the site. These methods may include silt fences, hay bales, sand bags, berms, silt, and debris basins.
  - Large projects shall be scheduled into phases that allow for erosion control of smaller areas rather than a single, large exposed site. Vegetation shall only be removed when necessary and immediately before grading.

- Excavation and grading work shall be scheduled for dry weather. These activities may be prohibited between the months of November and April.
- Slope stabilizers shall be utilized. These include natural fiber erosion control blankets of varying densities according to specific slope/site conditions.
- The restoration of natural erosion control shall be expedited to reduce risk of slope failure by immediately revegetating and irrigating until first one inch of rain.
- Fugitive dust shall be reduced by wetting graded areas with an adequate yet conservative amount of water. Grading operations shall be stopped in high winds (25 mph or greater).
- Recycling facilities shall be provided. Protocols for cleanup and disposal of small construction wastes (i.e. dry concrete) shall be developed.
- Protocol for identifying risk operations and materials shall be developed, including a
  protocol for identifying spilled-materials source, distribution, fate and transport of spilled
  materials.
- Protocols for proper clean-up equipment and construction materials, and disposal of spilled substances and associated clean-up materials shall be developed.
- An emergency response plan that includes contingencies for assembling response term and immediately notifying appropriate agencies shall be developed.

#### 2. Storm Water

The project shall comply with the local regulations associated with the Los Angeles Water Board's Municipal Stormwater Permit issued to Los Angeles County and co-permittees under NPDES No. CAS004001 and Waste Discharge Requirements Order No. R4-2012-0175.

#### H. On-Site Mitigation for Temporary Impacts

- 1. The Permittee shall restore all areas of temporary impacts to waters of the state.
- 2. Restoration shall include seeding with native species. Photos will be taken after seeding and sent to the Los Angeles Water Board to document completion.
- 3. The Los Angeles Water Board may extend the monitoring period upon a determination by Los Angeles Water Board Executive Officer that the performance standards have not been met or are not likely to be met within the monitoring period.

## I. Compensatory Mitigation for Permanent Impacts<sup>8</sup>

1. Final Compensatory Mitigation Plan The Permittee shall provide compensatory mitigation for impacts to waters of the state in accordance with Gate King – Compensatory Mitigation Memo (Compensatory Mitigation Plan) dated January 25, 2017 and incorporated herein by reference. Any deviations from, or revisions to, the Compensatory Mitigation Plan must be pre-approved by Los Angeles Water Board staff. The monitoring period shall continue until the Los Angeles Water Board staff determines that performance standards have been met. This may require the monitoring period to be extended.

#### 2. Total Required Compensatory Mitigation

- a. The Applicant shall provide compensatory mitigation to offset the proposed 2.33 acres of permanent impacts to jurisdictional waters by purchasing 2.91 acres of wetland rehabilitation credits from the Petersen Ranch Mitigation Bank. The Applicant shall also purchase 3.61 acres of upland Swainson's Hawk foraging credits from the Petersen Ranch Mitigation Bank, which will further mitigate the project's impacts by preserving upland areas which drain to jurisdictional waters, thereby improving their function and value. In addition, the Applicant shall enhance 6.68 acres of jurisdictional waters within the project site in Drainages DD and FF by removing non-native invasive species and trash from these areas prior to the completion of construction within each drainage and by completing planting activities as described in the January 25, 2017 Mitigation Plan. The Applicant shall also plant oak trees within 1.30 acres of jurisdictional waters within Drainage DD, Drainage FF, and/or the adjacent open space area that has been deeded to the City of Santa Clarita.
- **b.** Total required Project compensatory mitigation information for permanent physical loss of area is summarized in Table 4.

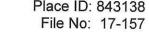

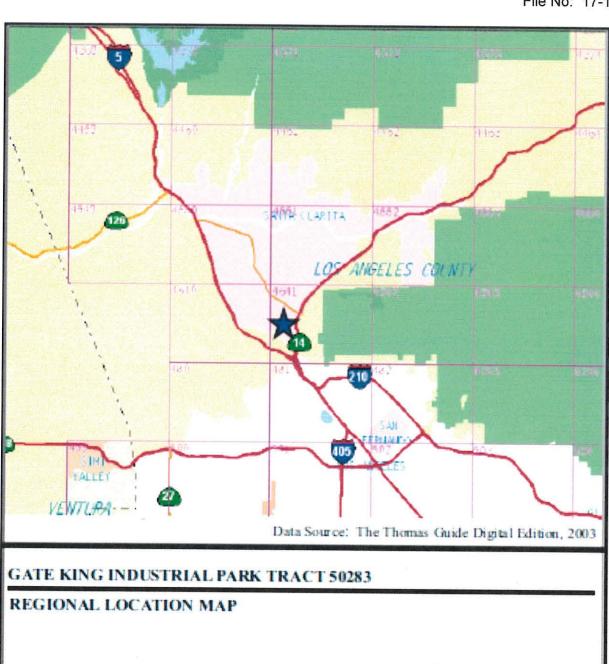

Approximate Project Location



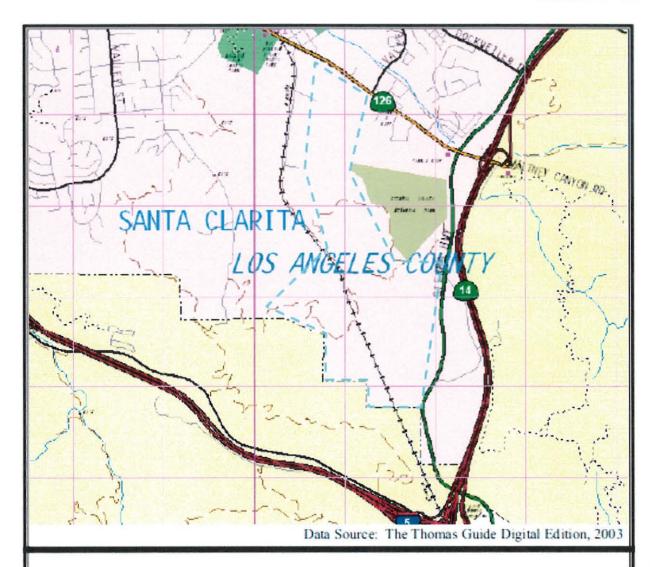

Approximate Project Boundary

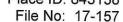


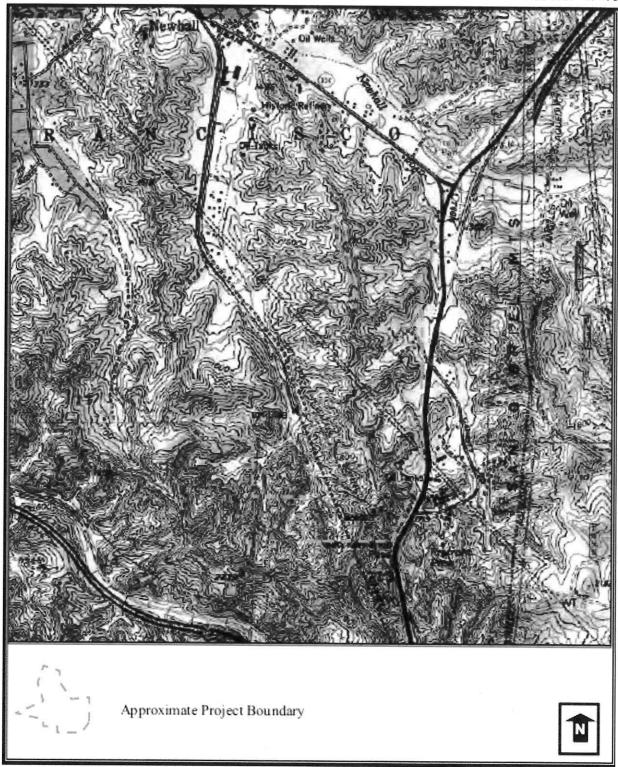

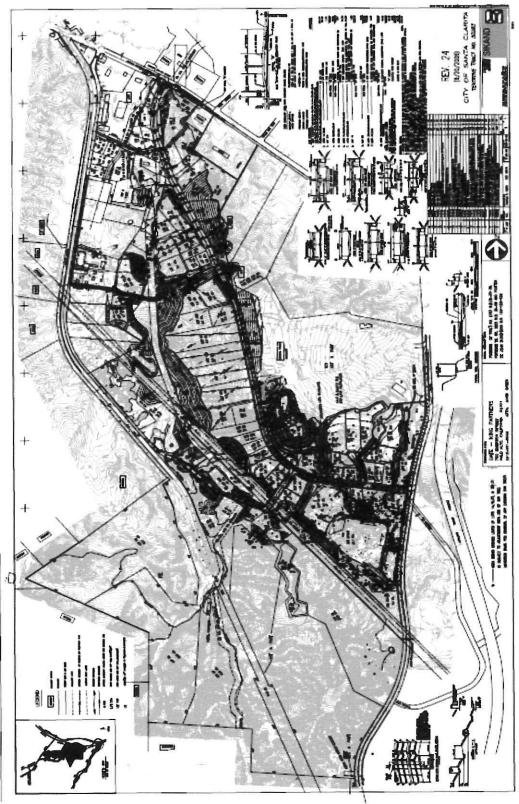

# **Definition of Reporting Terms**

- 7. Date of storm water Notice of Termination(s), if applicable.
- 8. Report status and functionality of all post-construction BMPs.

# Part C – Conditional Notifications and Reports

Report Type	Accidental Discharge of Hazardous Material Report
Report Purpose	Notifies Los Angeles Water Board staff that an accidental discharge of hazardous material has occurred.
When to Submit	Within five (5) working days following the date of an accidental discharge. Continue reporting as required by Los Angeles Water Board staff.
Report Contents	<ol> <li>The report shall include the OES Incident/Assessment Form, a full description and map of the accidental discharge incident (i.e. location, time and date, source, discharge constituent and quantity, aerial extent, and photo documentation). If applicable, the OES Written Follow-Up Report may be substituted.</li> </ol>
	2. If applicable, any required sampling data, a full description of the sampling methods including frequency/dates and times of sampling, equipment, locations of sampling sites.
	3. Locations and construction specifications of any barriers, including silt curtains or diverting structures, and any associated trenching or anchoring.

Report Type	Violation of Compliance with Water Quality Standards Report
Report Purpose	Notifies Los Angeles Water Board staff that a violation of compliance with water quality standards has occurred.
When to Submit	The Permittee shall report any event that causes a violation of water quality standards within three (3) working days of the noncompliance event notification to Los Angeles Water Board staff.
Report Contents	The report shall include: the cause; the location shown on a map; and the period of the noncompliance including exact dates and times. If the noncompliance has not been corrected, include: the anticipated time it is expected to continue; the steps taken or planned to reduce, eliminate, and prevent reoccurrence of the noncompliance; and any monitoring results if required by Los Angeles Water Board staff.

Report Type	In-Water Work and Diversions Water Quality Monitoring Report
Report Purpose	Notifies Los Angeles Water Board staff of the completion of in-water work.
When to Submit	Within three (3) working days following the completion of in-water work.  Continue reporting in accordance with the approved water quality monitoring plan.
Report Contents	As required by the approved water quality monitoring plan.

Report Type	Modifications to Project Report

Report Purpose	Notifies Los Angeles Water Board staff if the Project, as described in the application materials, is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority.
When to Submit	If Project implementation as described in the application materials is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority.
Report Contents	A description and location of any alterations to Project implementation. Identification of any Project modifications that will interfere with the Permittee's compliance with the Order.

Report Type	Transfer of Property Ownership Report
Report Purpose	Notifies Los Angeles Water Board staff of change in ownership of the Project or Permittee-responsible mitigation area.
When to Submit	At least 10 working days prior to the transfer of ownership.
Report Contents	<ol> <li>A statement that the Permittee has provided the purchaser with a copy of this Order and that the purchaser understands and accepts:         <ul> <li>a. the Order's requirements and the obligation to implement them or be subject to administrative and/or civil liability for failure to do so; and</li> <li>b. responsibility for compliance with any long-term BMP² maintenance plan requirements in this Order.</li> </ul> </li> <li>A statement that the Permittee has informed the purchaser to submit a written request to the Los Angeles Water Board to be named as the permittee in a revised order.</li> </ol>

Report Type	Transfer of Long-Term BMP Maintenance Report
Report Purpose	Notifies Los Angeles Water Board staff of transfer of long-term BMP maintenance responsibility.
When to Submit	At least 10 working days prior to the transfer of BMP maintenance responsibility.
Report Contents	A copy of the legal document transferring maintenance responsibility of post- construction BMPs.
