Dear Mr. Cwikia,

Cooper and Brain, Inc. operates eight small oil and gas leases scattered throughout your jurisdiction. All of these locations dispose of water through permitted sewer connections to Los Angeles County Sanitation Districts or with disposal wells (two locations) permitted with various agencies including California Department of Conservation-Division of Oil, Gas, and Geothermal Resources (DOGGR).

We have submitted production information on a monthly basis to DOGGR that notes fluid volumes produced and how they are disposed for as long as we have operated the facilities. I am not aware of any time where oil production and/or drilling fluids were discharged to sumps or ponds at any of these operations.

I have included with this letter a CD, which has the requested production and disposal information, as reported to DOGGR. Each lease has a unique file name with the related DOGGR Form 110 reports. Please note that this information is public record, maintained, and readily available for review to anyone on the Department web site.
