### Equipment Description :

CRUDE OIL / WATER SEPARATION SYSTEM CONSISTING OF:

1. WASH TANK, 9'-8" DIA. X 16'-0" H., FIXED ROOF (WITH ONE LINER FILTER), 200 BBL CAPACITY, CONNECTED TO THE GAS HANDLING SYSTEM.
2. WASTEWATER TANK, 8'-0" DIA. X 11'-6" H., FIXED ROOF, 103 BBL CAPACITY, CONNECTED TO THE GAS HANDLING SYSTEM.
3. CRUDE OIL SHIPPING TANK, 12'-0" DIA. X 15'-0" H., FIXED ROOF, 302 BBL CAPACITY, CONNECTED TO THE GAS HANDLING SYSTEM.
4. WASTEWATER DISCHARGE PUMP, CENTRIFUGAL, WITH A 5 HP ELECTRIC MOTOR.
5. CATCH BASIN, 5'-0" DIA. X 4'-0" H.
6. CATCH BASIN PUMP, CENTRIFUGAL, WITH A ¼ HP ELECTRIC MOTOR.
7. GAS HANDLING SYSTEM, DISCHARGING TO THE SALES GAS LINE, CONSISTING OF:
  - A. GAS HANDLING PIPING.
  - B. GAS COMPRESSOR.

### Conditions :

1. OPERATION OF THIS EQUIPMENT SHALL BE CONDUCTED IN ACCORDANCE WITH ALL DATA AND SPECIFICATIONS SUBMITTED WITH THE APPLICATION UNDER WHICH THIS PERMIT IS ISSUED UNLESS OTHERWISE NOTED BELOW.
2. THIS EQUIPMENT SHALL BE PROPERLY MAINTAINED AND KEPT IN GOOD OPERATING CONDITION AT ALL TIMES.
3. THIS FACILITY SHALL NOT BE OPERATED UNLESS THE WASH TANK, CRUDE OIL SHIPPING TANK AND WASTEWATER TANK ARE VENTED TO THE GAS HANDLING SYSTEM WHICH IS IN FULL USE.

4. ALL TANK GAUGING AND SAMPLING HATCHES SHALL BE CLOSED AT ALL TIMES EXCEPT DURING GAUGING AND SAMPLING OPERATIONS.
5. THE OPERATOR SHALL COMPLY WITH THE APPLICABLE REQUIREMENTS OF RULES 462, 463, 464, 466, 466.1, 1148.1, 1173 AND 1176.
6. ANY LIQUID HAVING A VOC CONTENT OF 5 MG PER LITER OR HIGHER SHALL NOT BE DISCHARGED TO OPEN CATCH BASINS, PITS, TANKS AND CLARIFIERS.
7. ALL RECORDS REQUIRED BY APPLICABLE RULES SHALL BE MAINTAINED IN A FORMAT APPROVED BY THE EXECUTIVE OFFICER, KEPT ON FILE FOR A MINIMUM PERIOD OF TWO YEARS, AND MADE AVAILABLE TO DISTRICT PERSONNEL UPON REQUEST.

**NOTICE**

IN ACCORDANCE WITH RULE 206, THIS PERMIT TO OPERATE OR COPY SHALL BE POSTED ON OR WITHIN 8 METERS OF THE EQUIPMENT.

THIS PERMIT DOES NOT AUTHORIZE THE EMISSION OF AIR CONTAMINANTS IN EXCESS OF THOSE ALLOWED BY DIVISION 26 OF THE HEALTH AND SAFETY CODE OF THE STATE OF CALIFORNIA OR THE RULES OF THE AIR QUALITY MANAGEMENT DISTRICT.
