- 2. SHIPPING TANK NO. E-194, 27'-9" DIA. X 8'-0" H., 800 BARRELS CAPACITY, FIXED ROOF, WITH A TRANSFER PUMP, RECIPROCATING, 60 H.P., AND VENTED TO A VAPOR RECOVERY SYSTEM.
- 3. SKIM TANK, 8'-0" DIA. X 6'-0" H., 50 BARRELS CAPACITY, FIXED ROOF, WITH A TRANSFER PUMP, CENTRIFUGAL, 1 H.P., AND VENTED TO A VAPOR RECOVERY SYSTEM.

- 4. THE OPERATOR SHALL COMPLY WITH THE APPLICABLE REQUIREMENTS OF RULES 463, 466, 466.1, 1148.1, 1173 AND 1176.
- 5. ALL TANK GAUGING AND SAMPLING HATCHES SHALL BE CLOSED AT ALL TIMES EXCEPT DURING GAUGING AND SAMPLING OPERATIONS.
- 6. ALL REQUIRED INSPECTION, MAINTENANCE AND REPAIR RECORDS SHALL BE MAINTAINED IN A FORMAT APPROVED BY THE EXECUTIVE OFFICER, KEPT ON FILE FOR A MINIMUM PERIOD OF TWO YEARS, AND MADE AVAILABLE TO DISTRICT PERSONNEL UPON REQUEST.

NOTICE

IN ACCORDANCE WITH RULE 206, THIS PERMIT TO OPERATE OR COPY SHALL BE POSTED ON OR WITHIN 8 METERS OF THE EQUIPMENT.
