Hey Joshua,

The Pacific Palms lease does not have any sumps or evaporation ponds of any sort at all. Simply put we produce total fluid into 1 large above ground steel tank 24/7. Water naturally drops to the bottom of the tank from the oil. This tank is additionally heated simultaneously as the heat helps seperate water from oil. The heated produced water is drained off the bottom with a small pump into another large above ground steel settling tank then gravity feeds through two (2) 3 part above ground steel clarifieing systems. So the water is basically allowed to settle and seperate 8 times before it is discharged into the sewer system. The produced fluid is also treated daily as it is produced with an emulsion breaking chemical that's whole purpose is to seperate water from oil. The water that is discharged into the sewer virtually looks like drinking water.
