4. WATER TANK, C-358, 9'-8" DIA. X 16'-0" H., 200 BBL CAPACITY, FIXED ROOF.
5. TWO WATER TRANSFER PUMPS, CENTRIFUGAL WITH PACKED GLAND, 5 HP AND 10 HP.
6. FOUR OIL / GAS SEPARATORS, EACH 3'-0" DIA. X 11'-0" H., PRESSURE HEADS.
7. TEST TANK, 3'-0" DIA. X 15'-0" L., PRESSURE HEADS.
8. VAPOR RECOVERY SYSTEM C-22 CONSISTING OF:
  - A. GAS BLANKETING / VAPOR COLLECTING LINES AND CONTROLS.
  - B. VAPOR RECOVERY COMPRESSOR, BLACKMER, PISTON TYPE, 7 HP.
9. TWO CHEMICAL TANKS, 220-GALLON CAPACITY, EACH WITH A METERING PUMP.
10. DRAINAGE PIT, 5'-0" W. X 5'-0" L. X 5'-0" D., 20-BBL CAPACITY, COVERED WITH A TRANSFER PUMP, AND A PRESSURE / VACUUM RELIEF VALVE.
