SUBJECT: NOTICE OF PUBLIC HEARING AND OPPORTUNITY TO COMMENT; PROPOSED AMENDMENT TO THE WATER QUALITY CONTROL PLAN TO INCORPORATE SITE-SPECIFIC CHLORIDE OBJECTIVES FOR REACH 6 OF THE LOS ANGELES RIVER

The California Regional Water Quality Control Board, Los Angeles Region (Los Angeles Water Board) will hold a public hearing on the proposed amendment to the Water Quality Control Plan (Basin Plan) to establish site-specific chloride objectives for Reach 6 of the Los Angeles River.

On November 16, 2023, the Los Angeles Water Board is expected to act on the proposed Order after hearing staff's presentation and public comments.

Title 23, Section 648.4).
