Announcement of Regional Board Perchlorate Public Advisory Group Meeting

I am pleased to invite you to attend the Regional Board's first Perchlorate Public Advisory Group (PPAG) meeting to provide an opportunity to share technical information related to perchlorate and to ensure that participants benefit from the perspectives of members of affected communities. Given the importance of perchlorate as a public policy issue, we have moved ahead to schedule the first meeting of this group for Friday, March 14th at 9 a.m. at the Regional Board's office in the Pacific Ocean Room, 2nd Floor, 320 West 4th Street, Los Angeles. In the event you are unable to attend this or forthcoming meetings, a summary of the meeting will be posted on our website to keep you informed.

As you may know, groundwater affected by perchlorate contamination is now affecting water supply systems within the Los Angeles Region. Federal, State and local regulatory agencies, in addition to water supply companies, are looking to the Regional Board to assist with identifying perchlorate contaminant sources. By establishing the PPAG, Regional Board staff are providing a forum to interested parties to discuss all aspects related to perchlorate and its impact on the environment Region-wide. PPAG meetings should provide an opportunity for all participants to exchange information relating to perchlorate including information on the latest regulatory actions relating to perchlorate investigations and cleanups, public health issues, analytical testing, and advances in treatment technology.

I understand the interest of members of the public in participating in PPAG meetings and the difficulty many will have in participating during work hours. To that end, I intend to schedule two evening meetings of the PPAG, over the course of the next year.




