**SUBJECT:** NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT ON PROPOSED TRASH MONITORING AND REPORTING PLAN SUBMITTED BY THE LOS ANGELES COUNTY FLOOD CONTROL DISTRICT (NPDES PERMIT NO. CAS004001; ORDER NO. R4-2012-0175 AS AMENDED BY STATE WATER BOARD ORDER WQ 2015-0075 AND LOS ANGELES WATER BOARD ORDER R4-2012-0175-A01)

The Los Angeles County Flood Control District (LACFCD) submitted a Trash Monitoring and Reporting Plan (hereinafter referred to as the "LACFCD TMRP") for Executive Officer approval.

The LACFCD TMRP does not include receiving water monitoring since the LACFCD are not assigned waste load allocations for the Los Angeles River Watershed Trash TMDL and the Ballona Creek Watershed Trash TMDL.
