The Rio Hondo/San Gabriel River Water Quality Group (RH/SGR WQG) which comprise of the Cities of Arcadia (4B190149001), Azusa (4B190151001), Bradbury (4B190155001), Duarte (4B190168001), Monrovia (4B190193001), and Sierra Madre (4B190209001), and the County of Los Angeles (4B190107099) and the Los Angeles County Flood Control District (4B190107101) continued implementation of the Coordinated Integrated Monitoring Program (CIMP) activities approved on June 29, 2015.
