SUBJECT: NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT ON PROPOSED

MODIFICATIONS TO THE NORTH SANTA MONICA BAY COASTAL WATERSHEDS COORDINATED INTEGRATED MONITORING

PROGRAM PURSUANT TO THE LOS ANGELES WATER BOARD REGIONAL PHASE I MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) PERMIT (NPDES PERMIT No. CAS004004; ORDER

No. R4-2021-0105)

The North Santa Monica Bay Coastal Watersheds Watershed Management Group¹ (Group) implements North Santa Monica Bay Coastal Watersheds (NSMBCW) Coordinated Integrated Monitoring Program (CIMP) under the Regional Phase I MS4 Permit, Order No. R4-2021-0105.

The NSMBCW CIMP was approved on April 30, 2024. On May 7, 2025, the City of Malibu submitted a letter on behalf of the Group to the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) requesting modification to the NSMBCW CIMP. To reduce duplicative monitoring for Benthic Community Effects in Malibu Creek; the Group intends to relocate the Malibu Creek receiving water monitoring location (NSMBCW-RW2) to the Las Virgenes Municipal Water District Tapia Water Reclamation facility receiving water monitoring location (RSW-MC004D). The Group noted the receiving water monitoring location in Malibu Lagoon (NSMBCW-RW2L) is adjacent to the Southern California Coastal Water Research Project (SCCWRP) receiving monitoring location (EMPA/BIGHT Station 2) and the Las Virgenes Municipal Water District Tapia Water Reclamation facility receiving water monitoring location (RSW-MC011D). Accordingly, the Group proposes to coordinate and rely on these existing monitoring programs for the Benthic Community Effects receiving water monitoring in Malibu Lagoon.
