CORRECTION OF MINOR TYPOGRAPHICAL ERROR ON LETTER OF APPROVAL, WITH CONDITIONS, OF THE MARINA DEL REY WATERSHED MANAGEMENT PROGRAM AGENCIES' WATERSHED MANAGEMENT PROGRAM (WMP) PURSUANT TO THE REGIONAL MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) WASTE DISCHARGE REQUIREMENTS AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR THE LOS ANGELES REGION (NPDES PERMIT NO. CAS004004; ORDER NO. R4-2021-0105)

Dear Marina del Rey Watershed Management Program Agencies:

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board or Board) on February 6, 2023 issued an approval with conditions of the revised Marina del Rey Watershed Management Program (MdR WMP) Plan dated June 30, 2021.

Please take note of the following minor typographical error in the afore mentioned letter that has been updated to state the correct watershed group that submitted the original draft WMP:

Original language, page 1: "This letter (1) conditionally approves the MdR WMP submitted by the **Malibu Creek** Watershed Management Group (Group) subject to additional revisions of the WMP, (2) reviews compliance metrics for Water Body-Pollutant Combinations (WBPCs) and (3) specifies additional requirements including requirements for an updated adaptive management process."

Corrected Language, page 1: "This letter (1) conditionally approves the MdR WMP submitted by the **Marina del Rey** Watershed Management Group (Group) subject to additional revisions of the WMP, (2) reviews compliance metrics for Water Body-Pollutant Combinations (WBPCs) and (3) specifies additional requirements including requirements for an updated adaptive management process."
