The State Water Resources Control Board (State Water Board) submitted this action for review under Government Code section 11353 to amend sections 3935, 3936, and 3939.13 in title 23 of the California Code of Regulations regarding amendments to the Water Quality Control Plan for the Los Angeles Region (Basin Plan). The Basin Plan amendments were adopted by the Los Angeles Regional Water Quality Control Board (Regional Water Board) on June 11, 2015 in Resolution No. R15-006. The State Water Board approved the Basin Plan amendments revise the total maximum daily load (TMDL) for trash in the Los Angeles River Watershed and the TMDL for trash in the Ballona Creek Watershed ensure consistency between the two TMDLs where appropriate, provide alternatives for demonstrating full compliance, include greater specificity regarding responsible entities assigned waste load allocations and load allocations, and expand monitoring requirements.

OAL approves this regulatory action pursuant to section 11353 of the Government Code.
