MODIFICATION TO WASTE DISCHARGE REQUIREMENTS
ORDER NO. 93-46 AND 93-83

FOR

CUMMINGS ROAD SOLID WASTE DISPOSAL SITE
CLASS III WASTE MANAGEMENT UNIT
(CHANGE OF OWNERSHIP)

Humboldt County

The California Regional Water Quality Control Board, North Coast Region, (hereinafter Regional Water Board) finds that:

1. This Order is to amend existing Regional Water Board Orders to recognize a change in a regulated facility's ownership. The existing Regional Water Board Orders are Waste Discharge Requirements Order Nos. 93-46 and 93-83. The new owner of the facility proposes no material changes to the character, location or volume of discharges authorized by the existing Waste Discharge Requirements Order Nos. 93-46 and 93-83, and none is authorized herein.
2. The facility is a municipal solid waste disposal site. The site is located at the south end of Cummings Road, two miles southeast of Eureka in the NE 1/4, Section 5, T4N, R1E, HB&M, 40° 60' 00" latitude, 124° 5' 30" longitude. The disposal site is situated on a 100-acre parcel designated as Humboldt County Assessor's Parcel No. 405-081-51F.
3. Humboldt Solid Waste Management Authority (Discharger) purchased the site from City Garbage Company of Eureka (Norcal Waste Systems, Inc.) on June 16, 2000.
4. The Regional Water Board has notified the Discharger and interested parties of its intent to amend the below-listed Regional Water Board Orders by substituting therein the current ownership of the facility.
5. The Regional Water Board heard and considered all comments pertaining to this Order.
6. This action is exempt from CEQA under Title 14, California Code of Regulations, Sections 15060(c)(2) and 15061(b)(3).

THEREFORE, IT IS HEREBY ORDERED that Waste Discharge Requirements Order Nos. 93-46 and 93-83 are hereby amended to reflect the new owner and operator of the site as follows:
