This letter is to notify you of observed and documented violations of the requirements listed below for unauthorized discharges to waters of the state from Sonoma County Assessor's Parcel Number 016-150-014 (Property):

- 1. California Water Code (Water Code) sections 13260, 13264 and 13376.
- 2. Federal Clean Water Act (CWA or Clean Water Act) sections 301, 401, and 404.
- 3. Water Quality Control Plan for the North Coast Region (Basin Plan) Section 4.2.1.

This letter directs you, within 30 days, to contact Regional Water Board staff to advise of your plan to comply with Water Code 13260.

The North Coast Regional Water Quality Control Board (Regional Water Board) is the public agency with primary responsibility for the protection of ground and surface water quality for all beneficial uses within the north coast portion of the State of California. The Regional Water Board issues permits for discharges or threatened discharges of

waste to waters of the state and Water Quality Certifications for dredge or fill activities within Waters of the United States, including wetlands.

On July 13, 2022, Regional Water Board (RWB) staff participated in a site inspection of the Property (see Attachment 1, Site Inspection Memo, Valley of the Moon Club, Santa Rosa). The inspection report documents and provides evidence of unpermitted activities that impact waters of the state and/or United States at the site.

By this letter, we are providing you notice that such activities violate provisions of the California Water Code and possibly the Clean Water Act, due to the unpermitted fill material placed on a flashboard dam and discharge of pre-mix concrete or fill into a stream, waters of the state and/or the United States (see Exhibit A, Regulatory Citations).

### **Property Background**

Regional Water Board staff (RWB staff) received a citizens complaint alleging unpermitted work on a flashboard dam located in Santa Rosa Creek on the Valley of the Moon Club golf course.

On July 13, 2023, RWB staff inspected the Property with Valley of the Moon Club representative King Wayman. The purpose of the inspection was to investigate the complaint alleging unpermitted work in Santa Rosa Creek. This inspection included an assessment of the impacts these activities had on water quality and the beneficial uses of waters of the state.

### **Relevant Requirements**

During the inspection, RWB staff observed features and conditions on the Property that represent violations of water quality requirements and regulations. Attachment A – Regulatory Citations, provides references to these requirements and regulations.

#### **Observed Violations**

Regional Water Board staff inspected the complaint site (latitude 38.4364, longitude - 122.5951) and confirmed the unpermitted fill in Santa Rosa Creek consisting of placing plastic tarp(s) over the flashboard dam and foundation and weighted down using 60 sandbags along the interior and broken concrete along the exterior of the dam. Premixed Sakrete concrete was used to plug two leaking holes in the dam apron. Records indicate the work was performed without a permit. The placement of tarp(s), sandbags, broken concrete, and pre-mix Sakrete in the stream are an unauthorized discharge to waters of the state. These items are also a threat to discharge pollutants to the stream including pH exceeding Water Quality Objectives in Santa Rosa Creek due to curing Sakrete contact with surface waters and plastic debris.

Placement of tarp(s), sandbags, broken concrete, and pre-mix concrete in the stream was not authorized by the Regional Water Board. These activities might also have required permits from US Army Corps of Engineers or the California Department of Fish and Wildlife. These unauthorized impacts have caused ecological degradation and loss of functions within the stream and threaten further discharges and degradation downstream.

Placement of fill material within the stream banks and bed of a water of the state including wetlands requires authorization from the Regional Water Board under section 13260 of the Water Code, and or section 401 (33 U.S.C. 1341) of the Clean Water Act and section 13376 of the Water Code, if the watercourse is also a water of the United States (see Exhibit A). You did not obtain authorization prior to this discharge and are currently in violation of these regulations. Additionally, the Water Quality Control Plan for the North Coast (Basin Plan) expressly prohibits the threatened discharge or discharge and/or placement of soil, slash, and other earthen materials into a water of the state in quantities which could be deleterious to fish, wildlife, or other beneficial uses (Exhibit 1 Basin Plan Section 4.2.1, Prohibition 1 and 2). Attachment 1 clearly documents your activities have discharged and continue to threaten additional discharges of prohibited materials and are in violation of these prohibitions.

#### Santa Rosa Creek

Santa Rosa Creek is tributary to the Laguna de Santa Rosa. The Laguna de Santa Rosa is tributary to Mark West Creek and eventually flows into the Russian River. The Property is located with the Russian River Hydrologic Unit, Middle Russian River Hydrologic Area, Santa Rosa Hydrologic Subarea 114.22. The existing and potential Beneficial Uses of Santa Rosa Creek and its tributaries include:

- Municipal and Domestic Supply
- Agricultural Supply
- Industrial Service Supply
- Industrial Process Supply
- Groundwater Recharge
- Navigation
- Hydropower Generation
- Water Contact Recreation
- Non-Contact Water Recreation
- Commercial and Sport Fishing
- Warm Freshwater Habitat
- Cold Freshwater Habitat
- Wildlife Habitat
- Rare, Threatened, or Endangered Species
- Migration of Aquatic Organisms
- Spawning, Reproduction, and/or Early Development

- Shellfish Harvesting
- Aquaculture

The Laguna de Santa Rosa and its tributaries have been designated as impaired for nutrients, dissolved oxygen, sediment, and temperature. Activities that may directly or indirectly impact beneficial uses of waters of the state require you to apply for a Clean Water Act section 401 Water Quality Certification and/or Waste Discharge Requirements (WDRs). These activities might also require input, consultation, and permits from other federal, state, and local agencies.

### Non-compliance and Enforcement

Please note that correcting the conditions of non-compliance at the sites does not preclude enforcement for the violations alleged in this notice. The following sections of the Water Code may apply to the activities: 13261(a), 13264 (a), 13265(a), 13304, 13350, 13385 (See Exhibit A). The Regional Water Board reserves its right to fully enforce the law against any violation and threatened violation by taking enforcement actions. Discharges or threatened discharges of waste, including earthen material, into waters of the state and/or United States that create a condition of nuisance or pollution may subject a person to a Cleanup and Abatement Order pursuant to Water Code section 13304. An actual discharge to waters of the state, including allowing fill to remain within a water of the United States, may subject a person to an administrative liability up to \$5,000 per day of violation for each violation, or \$10 for each gallon of waste discharged pursuant to Water Code section 13350. Unlawful discharges to waters of the United States and/or violations of the Clean Water Act may subject a person to up to \$10,000 per day of violation for each violation, and up to \$10 per gallon of waste discharged over 1,000 gallons not cleaned up pursuant to Water Code section 13385. The Regional Water Board retains its discretion to refer this matter to the Attorney General for enforcement. We will contact you upon further assessment of these violations to discuss any potential associated civil liability or other enforcement actions.

#### Recommendations

The July 17, 2023 Inspection Report documents and provides evidence of unpermitted impacts to waters of the state and/or United States at the Property. To correct violations and address features and conditions that threaten to impact water quality described in the inspection report, we recommend that you do the following:

1. Within 30 days of receipt this letter, contact Gil Falcone at Gil.Falcone@waterboards.ca.gov or (707) 576- 2830 and Scott Gergus at scott.gergus@waterboards.ca.gov or (707) 576-2685 of the Clean Water Act section 401 Certification Unit to discuss your plan to correct the violations. This plan should include an evaluation of the dam in Santa Rosa Creek, including a timeline for replacement of the dam.

2. By March 30, 2023, submit a Water Quality Certification and/or Waste Discharge Requirements (Dredge/Fill Projects) (individual 401 application packet) addressing the continued annual installation and removal of tarp(s), sandbags, and broken concrete from the flashboard dam. In addition, the 401 application must include an evaluation of the flashboard dam and appurtenant structures in its current condition and replacement of the existing dam and appurtenant structures to bring the site back into compliance.
