Resolution No. R1-2021-0006
Groundwater Basin Evaluation and Prioritization Results
Supporting Salt and Nutrient Management Planning

Staff presents Resolution No. R1-2021-0006 (Resolution) for consideration by the North Coast Regional Water Quality Control Board (Regional Water Board), recommending Priority Basins that would benefit from Salt and Nutrient Management Planning. A Staff Report accompanies the resolution and describes the technical approach used to evaluate and prioritize the 62 groundwater basins in the North Coast Region. This item will be open for written public comment between January 4, 2021, and February 3, 2021.

Public Hearing Procedures

A public hearing to consider the proposed Resolution and receive public comment is scheduled for the Regional Water Board's April 15 or 16, 2021 meeting as announced in the Regional Water Board's agenda.
