8. **Groundwater Cleanup Programs** in the North Coast Region

Kasey Ashley and Luis Rivera, Regional Water Board staff, gave a brief overview of the process used by Cleanups staff to cleanup and abate discharges to the environment for two programs, underground storage tanks and site cleanup.

9. Executive Officer's Report

Catherine Kuhlman referenced the written Executive Officer's Report that lists the 2009 Regional Water Board's accomplishments.

She also reported that:

- The State Water Resources Control Board has put out a notice for solicitation for water quality data for the 303 (d) list for 2012;
- That the January 20^{th,} 150,000 gallon spill of raw sewage in the Laguna from the city of Sebastopol has stopped and the Health Department is in charge of necessary posting; and
- A discharge, due to the earthquake and rain, in a construction job on Fern Street in Eureka is now stabilized. Workers are working with City of Eureka and NOAA.

10. Board Member Requests for Future Agenda Items

Board member Noren requested that the Cleanup Unit give an update to the board on Resolutions that come out of the State Board and how the Resolutions affect the staff and their workload.

Geoff Hales requested an update or progress report on the Triennial Review.
