4. **National Oceanic and Atmospheric Administration (NOAA) Fisheries Draft Multispecies Recovery Plan.** Korie Schaeffer, Operations and Policy Branch Chief, NOAA and Erin Seghesio, Recovery Coordinator, NOAA, introduced themselves to the Board. Ms. Seghesio gave a presentation on the Multispecies Recovery Plan with geographical locations, population structure, diversity and viability, outlining the recovery goals, objectives and actions for each Salmonid species (California Coastal Chinook Salmon, Evolutionarily Significant Unit (ESU), Northern California Steelhead, Distinct Population Segments (DPS) and Central California Coast Steelhead DPS) and the many opportunities for NOAA/National Marine Fisheries Service (NMFS), and the North Coast Regional Water Quality Control Board to align, leverage and implement the Multispecies Recovery Plan.

4. **Update on Water Rights and Fisheries Management Actions in the Russian River Watershed.** Bryan McFadin, Senior Water Resource Control Engineer, Flow & Riparian Protection Specialist introduced: Dan Worth and Dan Schultz, State Water Board, Division of Water Rights; and Corrine Gray, California Department of Fish and Wildlife. Ms. Gray gave a presentation on the Voluntary Drought Initiative (VDI) Flow and Conservation Agreements in the Russian River

tributaries of Green Valley Creek; Dutch Bill Creek; Mill Creek; and Mark West Creek; that enhanced critically low summer flows to protect juvenile salmonids. Mr. Schultz gave an overview of the Russian River Tributaries Emergency Regulations, response to comments to the Informational Order and the potential short term actions. Mr. Worth gave an overview of the California Water Action Plan instituted by Governor Brown to guide State efforts to (1) Enhance water supply reliability; (2) Restore damaged and destroyed ecosystems; (3) Improve resilience of California's infrastructure and outlines California's near- and long-term water priorities, including drought. The watersheds identified in the North Coast region are: Mark West Creek; Shasta River; and South Fork Eel River; and contracts are being developed for hydrology and groundwater modeling; water rights evaluation tools; identifying gauging needs and compiling and evaluating existing information.
